- Q1. The current minimum wage for all staff is \$17.00 per hour, however the RFP states a minimum of \$15 per hour. Can you please confirm that the County prefers/requires a \$17 minimum hourly wage?
- A1. Refer to section 5.7 (f), if your company has a higher starting wage, then you have met the criteria as outlined
- Q2. Can you please provide the average daily population for the last six months?
- A2. July 575, August 586, September 636, Oct 636, Nov 666
- Q3. Page 2 of the RFP, Section 4.10. states "The current meal pattern is hot cold hot" Would you like to continue with this menu pattern?
- A3. There must be a minimum of 2 hot meal and dinner must be one of them.
- Q4. Page 3 of the RFP, Section 5.5. States "No pork, no seafood, no peanut products in any standard inmate meals." Please confirm that peanut butter cannot be provided on the standard adult menu, but may be included on religious menus.
- A4. Confirmed, if appropriate, cleared by medical and not in proximity to inmates with a sensitivity to the allergen
- Q5. The current standard inmate menu at Fairfax County provides a weekly average of 2900 calories PER DAY. Would you like to continue with this same amount?
- A5. Meals should be about 2900 calories per day. Unless medically indicated
- Q6. The current standard inmate menu at Fairfax County provides 2% milk cartons at breakfast daily. Would you like to continue to provide carton milk at breakfast daily?
- A6. Yes unless there is an appropriate substitution that will meet caloric and dietary needs for the entire ADC population
