The referenced Request for Proposal is amended as follows:

1. The following are additions being made to Attachment B:

ADD: The following paragraphs to Technical Provisions, paragraph 20.

- 20.5. All recyclables collected in service of this contract should be deposited into appropriate building dumpsters loose (unbagged). The County's recyclables processing vendor does not accept recyclables in plastic bags.
- 20.6. Zero Waste Custodial Support. The County is in the process of developing and implementing a Zero Waste Plan for county operations. To assist the County in realizing these goals, offerors are encouraged to address the following details in their proposals:
 - a. Outline experience supporting clients with zero waste or recycling goals.
 - b. Address how changes to material collection would be addressed after the contract start date. Examples of separate material collection being considered are food scraps/organics, cardboard & paper, etc.
 - c. Offerors are encouraged to propose additional zero waste custodial support services that would help the county achieve its goals. Examples include: a zerowaste training program for custodial staff, reporting of contamination observed during collection (using oops tags, etc.), assistance with other zero waste reporting efforts such as presence of recycling bins, assistance operating waste stations at special events, etc.
