FirstNet PSAP Backup solution description:

Each year, 9-1-1 centers in the U.S. receive an estimated 240 million calls. Today's technology allows people to communicate faster than ever. And public safety needs to communicate just as easily. The AT&T ESInet™ Next Generation 9-1-1 (NG9-1-1) call routing service now supports interconnection with the FirstNet® public safety broadband network to increase reliability.

With FirstNet, AT&T ESInet extends network connectivity to remote Public Safety Access Points (PSAPs) that may be experiencing an outage. FirstNet wireless connectivity provides a cost-effective alternative to special construction charges.

Private Mobile Connection:

AT&T ESInet™ uses the FirstNet Private Mobile Connection (PMC) service to allow:

- Highly secure connectivity between the PSAP and the AT&T national NG911 ESInet infrastructure
- AT&T ESInet to connect to PSAP endpoints to deliver IP-based 9-1-1 call traffic without using the public internet

And should AT&T ESInet detect a failure of the primary connection to the PSAP, the service automatically routes calls over the FirstNet connection.
