- a. Add as a new Section 13 to Exhibit D (Fairfax County's Terms and Conditions) to SAP Public Services, Inc. Software License Agreement effective August 13, 2009 with Fairfax County, the following:

13. COMPLIANCE WITH FEDERAL, STATE, AND COUNTY LAWS

13.1 The Contractor agrees that it is and will remain in compliance with all applicable federal, state, and local laws, rules, and regulations that may be in effect during the term of the Agreement as they apply to the operation of the Contractor's business with respect to the provision of Software and Support.

- b. Add as a new Section 14 to Exhibit D (Fairfax County's Terms and Conditions) to SAP Public Services, Inc. Software License Agreement effective August 13, 2009 with Fairfax County, the following:

14. NON-DISCRIMINATION

14.1 During the performance of this contract, Contractor agrees that it will not discriminate against any employee or applicant for employment because of race, creed, color, sex, religion, national origin, age, disability, veteran status, or any classification protected by applicable laws.
