Contract 4400008187 is modified to change the contract number to 4400012761; and

Supplier Id. assigned to PowerSchool Group LLC is 1000038871.

2. Renewed the Contract for one (1) year effective July 1, 2024, through June 30, 2025. This is the second of five (5) one-year renewals.


