

This addendum (the "ADDENDUM") dated June 18th, 2015 is a material part of the Cable Broadcast Agreement Blanket License, Master and Synchronization Agreement (the "AGREEMENT") commencing July 1st, 2014 by and between Killer Tracks, a unit of Universal Music – MGB NA LLC, 2110 Colorado Avenue, Suite 110, Santa Monica, CA, 90404 (hereafter referred to as "KT"), and Fairfax County Government Channel, 12000 Government Center Parkway, Suite 133, Fairfax, VA, 22035 (hereafter referred to as "COMPANY"). This ADDENDUM modifies, supplements, and/or amends the terms of the AGREEMENT only to the extent expressly set forth herein.

WHEREAS KT is supplying CDs from the **KILLER TRACKS PRODUCTION MUSIC LIBRARY** (hereafter referred to as "LIBRARIES") for use by the COMPANY, the articles granted in the COMPANY's AGREEMENT, dated June 12th, 2014, hereby govern the terms of this ADDENDUM.

- C. **The term of this ADDENDUM shall commence on June 18th, 2015 and conclude on June 30th, 2017.**
- D. The terms of the ADDENDUM may not be changed or modified except by written agreement of both parties. All other terms, provisions and conditions of the AGREEMENT that this ADDENDUM does not modify specifically shall remain unchanged and in full force and effect.
