- A3. Other jurisdictions utilizing a Fairfax County contract are between the jurisdiction and the contractor, Fairfax County does not know the spend or if other jurisdictions are utilizing the contracts.
- Q4. I see the bonding requirement is set for (\$10M) ten million dollars. Most of the projects under the previous contract have been a lot less. A bonding amount that is that high would normally be set for a general contractor covering all trades for a complete renovation or new construction project. If the work under this contract will not be ten million dollars can this bonding requirement amount be lowered?
- A4. The bonding requirement will remain at \$10M. There are multiple County agencies and Fairfax County Public Schools who may have multiple projects going at one time.
