By mutual agreement, Contract 4400009131 is hereby amended as follows:

RATIONALE:

For the purposes of calculating the total number of required maintenance technicians per 11,000 platform hours of Connector service, apprentice mechanics in training (up to 6) and technical support supervisors (up to 4) are counted as one for one in the platform hour ratio calculations. The position changes listed below will be administered in accordance with all other contract requirements and associated clauses.

- 1. Supervisors, as required in SPECIAL PROVISIONS, ANNEX-1, SECTION 4, STATEMENT OF QUALIFICATIONS and TRANSDEV'S TECHNICAL RESPONSE SECTION 4A, are reduced by 6 positions, with each position being replaced by a Chief Supervisor. The change brings the total number of Chief Supervisors to 9 positions (3 in each division).
- 2. Supervisors, as required in SPECIAL PROVISIONS ANNEX-1, SECTION 4, STATEMENT OF QUALIFICATIONS and TRANSDEV'S TECHNICAL RESPONSE SECTION 4A, are reduced by 1 position and replaced by a new Director of Safety position. The existing safety director position is retained and reclassed as safety/training manager reporting to the new Safety Director.
- 3. A total of up to 6 maintenance technician positions are reduced from the requirements of certified technicians and replaced with apprentices. Each apprentice participant must meet the established criteria as agreed to by the County and Transdev (Transdev Services Inc. Apprenticeship Program memorandum dated May 9, 2022). Each maintenance apprentice will count as one (one apprentice equals one maintenance technician), with a maximum of 6 full-time apprentices participating in the program at any time, provided they remain in the training program.
- **4.** A total of 4 technicians are reduced from the requirements of certified technicians and are replaced with Technical Support Supervisors (one located in each bus division and one in the IT shop).
- **5.** Transdev agrees to hire an additional program administrator to support the apprenticeship program and advance the development of zero-emission technology training curriculum.

All other terms and conditions remain unchanged.
