By mutual agreement, Contract 4400008424 is amended as follows:

- 1) Contract is renewed through June 30, 2026.
- 2) Effective July 1, 2025, increase all catering prices by 3%.

- 3) Emergency Re-Delivery Service:

Continue to provide emergency re-delivery service for Home Delivered Nutrition clients who miss their regular weekly delivery and need to have an alternate delivery made on Fridays. Jeffery's Catering will continue to provide this delivery service at \$35.00 per delivery.

- 4) Add Mandated Reporter Language:

The contractor is a mandated reporter pursuant to 63.2-1606 of the Code of Virginia. This means the contractor is required to report or cause a report to be made to Virginia Adult Protective Services (APS) either by calling the Fairfax County APS Hotline (703-324-7450), the Virginia state APS Hotline (888-832-3858) or using the State APS Online Reporting Portal (<https://www.dars.virginia.gov/aps/APSreport.htm>) whenever the contractor has reason to suspect that an adult age 60 or over or an incapacitated adult age 18 and over and who is known to the contractor in their professional or official capacity may be abused, neglected or exploited. The contractor understands that they must follow their reporting protocol, if any, and their employer may not prohibit them from reporting directly to APS.
