- Q1) Can a foreign entity apply for this contract without a representative in the US?
- A1) Refer to Paragraph 26.1 of Special Provisions and Paragraph 61 of Appendix A for foreign business entities.
- Q2) Are there multiple locations that will be served? If so, can they be provided.
- A2) Per Paragraph 6.2 of the Special Provisions, deliveries will be made to various locations in Fairfax County, including but not limited to:
 - Alban Maintenance Facility 7245 Fullerton Road Springfield, VA 22150
 - Jermantown Maintenance Facility 3609 Jermantown Road Fairfax, VA 22030
 - Newington Maintenance Facility 6900 Newington Road Lorton, VA 22079
 - West Ox Maintenance Facility 4612 West Ox Road Fairfax, VA 22030

In addition, per Paragraph 23 of the Special Provisions, the resulting contract(s) may be extended to other public bodies with the authorization of the Bidder, which would include deliveries to various locations.

- Q3) Is there a minimum quantity of batteries per order?
