- Q1. Is there a way that we could get a copy of a basic floor plan or emergency contingency plan for Old Mt. Vernon High School and the South County Government Center?
- A1. **The county will not provide basic floor plans and or emergency contingency plans.**
- Q2. We need to clarify whether or not floors 3 and 4 of the South County Government Center will receive full service, reduced service like the north east corners (juv. judicial and admin) of floors 1 and 2, or no service at all?
- A2. **South County Government Center requires full cleaning service for the entire building per Section 4.2 of the Special Provisions.**
- Q3. Old Mt Vernon High School - What is the sq.ft for the teen center?
- A3. **The Teen Center plus the Senior Center has a gross square footage of 40,000 SF.**
- Q4. South County Govt Center - What is the typical daily occupancy for the building? Who is responsible for supplying Purell? Are paper towels or soap supplied to kitchens? How many clinic rooms are there in the building that would require soap and paper towels?
- A4. **The daily occupancy for the building is unknown. Hand sanitizers inside of the public bathrooms is the responsibility of the Contractor, any hand sanitizers within the tenant's space is the responsibility of the tenant. The exact number of clinic rooms is unknown, there may be approximately 20 to 40 rooms.**
- Q5. Mt Vernon High - Will this include the Senior Center like its stated in Amendment 7?
- A5. **Yes, please see response to Q3 above.**
- Q6. Is there night cleaning at Alban Garage?
- A6. **Please see Section 4, Item 4.2, number 2.**
