RFP CLARIFICATIONS:

The following are responses to questions received via Bonfire:

- Q1. Could FCPS please provide approximate quantities for "Optional Packing and Preparation Services"? Knowing the quantities will help vendors calculate costs correctly.
A1. For informational purposes: This primarily applies to large scale deployments that are part of our 1 to 1 program called FCPSOn. We are moving to a 4-year refresh cycle that will include approximately 47,500 annually. Quantities are estimates and dependent on allocated budgets.
- Q2. Could FCPS please provide approximate quantities for the "Mobile Labs" charging station? Knowing the quantities will help vendors calculate costs correctly.
A1. For informational purposes: Approximate quantity of 200 mobile labs/ yr. assuming a 4-year fresh cycle to cover about 15% of classrooms. Quantities are estimates and dependent on allocated budgets.
- Q3. What are the estimated quantity breakdowns of systems by category per year? This information will help vendors calculate the most advantageous pricing.
A3. Devices are refreshed typically on a 4-year cycle by grade level, so an annual breakdown is rather challenging. Below is an approximation based on current trends:
- Teacher laptops: 4,500.
 - Administrative: 100.
 - FCPSOn Student Devices: ~47,000.
 - Lab Systems: 25, 28-32 station carts.
- Quantities above are for informational purposes, are estimates and dependent on allocated budgets.
- Q4. In Section 7.2.9 for Tablets, there is no OEM designated in the description. Can a vendor propose any brand tablet or are we confined to Dell, HP, and Lenovo? Additionally, Tablets are not included in the Pricing Summary. Will FCPS be revising the Pricing Summary to include Tablets?
A4. Offerors are not confined to brands of Tablets. The Pricing Summary will not be revised to include Tablets. Offerors may revise the Price Summary to include Tablets if they choose.
- Q5. For Section 7.2.7 Mobile Labs, will FCPS accept solutions from OEMs other than Dell, HP, and Lenovo? Additionally, Mobile Labs are not included in the Pricing Summary. Will FCPS be revising the Pricing Summary to include Mobile Labs?
A5. FCP will only accept Dell, HP and Lenovo Mobile Labs. Offerors may revise the Pricing Summary to provide the best response to the requirements.
- Q6. In response to Question/Answer 14 on Addendum 2 referencing Appendix E where FCPS stated "Yes, we expect a breakdown," please confirm the following:

- A. The following table, which now includes a column for the corresponding Discount off list as well as the addition of Lab Systems and Chromebooks to mirror Appendix D, is compliant.
- B. Within a product group, bidders can propose more than one model with a corresponding Discount off List in order for FCPS to receive the best Unit Price for the different models.
