- Effective January 1, 2020, PowerSchool Group, LLC ("PowerSchool") acquired all assets of Schoology, Inc. ("Schoology") by merger of Schoology into a subsidiary of PowerSchool. As a consequence of the acquisition and merger, PowerSchool assumed all obligations and rights of Schoology pursuant to Contract 4400009171, dated June 25, 2019, between Schoology and Fairfax County Public Schools.

5. Section 5-Third Party Software, Sub-section C-Blackboard Ally is updated to read as follows: :

License cost for FCPS is \$1 per student per year. In addition to licensing, the integration of Ally functionality into Schoology requires software development work by both Blackboard and Schoology. Schoology commits to the software development required for integration with Blackboard Ally in a milestone approach with an initial release of March 31, 2021 and a completion date of no later than August 15, 2021. Further milestones will be defined in collaboration with PowerSchool, FCPS and Blackboard. Collaboration with FCPS regarding the definition of the milestones will begin in October of 2020.
