

4.42. CONTRACTOR PROVIDED LEASED OR PURCHASED BUSES

4.42.1

The County may determine that additional buses are required to meet short-term service demands. If such needs arise, the County may negotiate with the Contractor to purchase or lease buses or vehicles. Upon any such request, it shall be the responsibility of the Contractor to locate and negotiate the price for any leased or purchased buses. The price to the County for leased or purchased buses will be specified in the pricing page of the Offeror's proposal. The Contractor-provided purchased or leased buses are eligible for the County fueling program.

All other terms and conditions remain the same.
