To compete, companies must demonstrate tech readiness and Accolade Partners is a venture capital fund and growth equity fund of funds focused on funding software technology and health-care focused companies. Accolade targets emerging seed and series A fund Bethesda Green describes itself as a sustainable urban ecosystem that creates opportunities for environmental civic engagement, education, government partnership, and innovative business Black Girl Ventures is a venture capital firm focused on funding tech-enabled, revenue generating businesses founded by people who identify as a black or brown women. The firm's mission is to provide black and brown founders with access to community capital and capacity building. Black Girl Ventures's BGV Pitch Program gives business access to capital through live crowd-funded pitch competitions. Successful Pitches may win up to \$10,000. The firm also offers a training program to create ecosystems Booz Allen Ventures is the investment branch of Booz Allen Hamilton. The Booz Allen Ventures fund invests in early-stage technology companies seeking to introduce disruptive technologies to the public sector. The fund has a particular interest in supporting technologies that align with the Department of Camber Creek is a strategic venture capital firm focused on funding real estate tech companies. The organization sources potential investments for their angel investors and provides investor-focused training and education. Entrepreneurs are connected to the Citrine Angel network through pitch competitions. Citrine Angels also offers and local government. The start-up program offers participants access to a network of key stakeholders, mentorships, consulting, communications support, and in-kind corporate expertise, products, and platforms. CivStart's services are cost based and startups incur a \$10,000 fee for participation. Start-ups of all stages may apply for the accelerator program, as long as they have proven solutions and teams. Big Idea's Connectpreneur is a global community of 25,000 entrepreneurs, venture capitalists, chief executive officers (CEOs), and chief experience officers (CXOs). The network offers startups mentorship, support, and resources for capital raising. Connectpreneur's investor network provides early stage entrepreneurs access to over 15,000 high net worth angel, family office, venture capitalist, and D code is a venture capital firm focused on developing technology solutions for the federal government. The firm offers three programs: 1.Dcode for Tech; 2. Dcode for Partners; 3. Dcode for Government. The Dcode for Tech acceleration program for companies to enter and scale their products in federal markets.

DC Archangels Training Institute identifies top global investment ready companies and connects them to the organization's active investment community. DC Archangels uses its certificate programs to promote relationship building between investors and entrepreneurs. The institute offers two programs. The Investment Skills Program has been designed for investors and entrepreneurs to learn the aspects of Enlightenment Capital provides private investment and strategic support for middle market aerospace, Foundry is an NSIN program powered by FedTech. The National Security Innovation Network (NSIN) is a program office within the U.S. Department of Defense that seeks to build networks of innovators that Goodie Nation provides underrepresented and historically marginalized founders access to networks of support. The organization seeks to address the "relationship gap", or the lack of mentorship and robust relationships that can diminish the success of entrepreneurs who identify as people of color, women, or The Hack Factory is a start-up lab in the DC metro region that offers support for rapid technology prototyping for disruptive technologies. The lab offers capital, co-working space, and networking. Hack Halcyon House offers programs for "impact-driven" early stage (pre-seed and seed) start-ups and entrepreneurs. Creating Key Partnerships. ICAP touts technical assistance and improved access to grants and federal funding opportunities as a benefit of JFF Labs is a branch of the Jobs for the Future consultant firm focused on promoting social innovation in national workforce and education systems. JFF Labs invests in early-stage companies and entrepreneurs to advance inclusive technology solutions through its Employment Technology Fund focused on developing innovative solutions that increase access to learning, employment, and economic Lockheed Martin Ventures is a subsidiary of Lockheed Martin that is dedicated to making investments in the technologies and markets of interest to the company. Artificial intelligence, autonomy and robotics, cyber security, electronics, materials and manufacturing, and communication technologies are among the Mach 37 is a seed accelerator program, a program that provides matching grants and consultation to support the development of businesses, fully owned and operated by Venture Scope. The program serves cyber technology companies, through its mentorship network. The mentorship network is comprised of government, financial services, insurance, and energy cyber professionals. Mach 37's programming The National Science Foundation offers seed capital to high risk early-stage product companies.
