## Electoral Board Meeting

Pursuant to Va. Code § 24.2-671, the Fairfax County Electoral Board will meet beginning at 10:00 a.m. on Wednesday, March 4, 2026, subject to recess and reconvening, to canvass the returns and ascertain the results of the Special Election, Member, School Board, Braddock District, held on Tuesday, March 3, 2026. This meeting will be held in Conference Room 251, Fairfax County Government Center, 12000 Government Center Parkway, Fairfax. General election matters may be discussed.

Additionally, pursuant to Va. Code § 24.2-653.01, the Electoral Board will meet beginning at 12:00 p.m. on Wednesday, March 4, 2026, subject to recess and reconvening, to determine the qualifications of each person, if any, who submitted a provisional ballot for the Special Election, Member, School Board, Braddock District, held on Tuesday, March 3, 2026. The Board will go into a Limited Access/Closed Session to consider the qualifications of provisional voters. Other than appropriate staff and legal counsel of the Electoral Board, attendance at this meeting shall be permitted for the persons whose provisional votes are being considered with their legal counsel, if present, as well as one authorized representative of each political party or independent candidate. Authorized representatives must be qualified voters in the Commonwealth of Virginia.
