Date: December 11, 2017

Pursuant to the Court's Order in Tanner v. Hugo, and consistent with the provisions Section 24.2-633 of the *Code of Virginia*, notice is hereby given that the preparation, testing, and sealing of voting equipment to be used in the Recount of the 40<sup>th</sup> House District will be conducted on Wednesday, December 13, 2017 at the Fairfax County Courthouse. This will occur on the fourth and fifth floors of the Courthouse in the jury assembly rooms.

Preparation, testing, and sealing of voting equipment will commence at 8 a.m. for the voting equipment of Prince William County. Immediately following that process, preparing, testing, and sealing of the voting equipment of Fairfax County will commence.

In accordance with the order of the Court, the machines shall be tested to the specific results and separation of the ballots defined within the Order.

By order of the Court, each party is entitled to have one observer present to observe the testing process, in addition to legal counsel for each party. The observers and legal counsel shall have an unobstructed view of the testing and shall be permitted to see the displays on any counting device. The testing shall comply with all aspects specified in the Court's Order in this matter.
