#### MINUTES Fairfax County Electoral Board April 12, 2023

The Fairfax County Electoral Board (Board) met on Wednesday, April 12, 2023, in Conference Room 315 at the Fairfax County Government Center located at 12000 Government Center Parkway, Fairfax. Chairman Hon. Katherine K. Hanley; Vice Chairman Jeffrey K. Shapiro; Secretary Amb. (ret.) Christopher P. Henzel; General Registrar Eric L. Spicer; Deputy General Registrar Cheryl Jones; and Clerk to the Electoral Board Beth Dixon Methfessel were present.

IT Manager Cord Whitehouse; Election Operations Manager Ravi Udeshi; Deputy Registrar for Voter Registration Bushra Ardalan; Deputy Registrar for Voter Satellite Offices Helen Chaikovsky; Deputy Registrar for Absentee Voting Sean Stewart; Supply Manager Kay Garrison; Training Specialist Alina Selnick-Escobar; Jean Thoensen and Todd Strelow (Office of Elections (Office) staff); Gregory Brandon (Fairfax County Democratic Committee (FCDC) Central Communications); Peggy Morrison (FCDC Voter Registration and Education); Maggi Luca (Fairfax, League of Women Voters (LWV)); Christine Brim and Andi Bayer (Fairfax County Republican Committee (FCRC) Election Integrity Task Force); Barbara Palmer-Tengs (member FCRC); and Jill Mobley (Fairfax County election officer and/or resident of Fairfax County) also attended the meeting in person.

Ms. Hanley called the meeting to order at 4:01 p.m. and introduced the Board. Mr. Henzel moved approval of the agenda, and the motion passed by a vote of 3-0. Mr. Henzel made a motion to adopt the Draft Minutes of the Board meeting held on March 26, 2023. By a vote of 3-0, the Minutes of the Board meeting held on March 26, 2023, were adopted.

Under the General Registrar's (GR) report dated April 11, 2023 (attached and made a part of this record), Mr. Spicer updated the voter registration numbers since the last Electoral Board meeting:

Mr. Spicer also provided the following table updating the results of the Department of Elections (ELECT) first of two 2023 National Change of Address (NCOA) confirmation mailings.

Mr. Spicer explained that ELECT recently issued an advisory providing localities with a new death lookup process. General Registrars are now authorized to use an obituary posted in a newspaper distributed within the locality or the website of a licensed funeral home to help confirm that an individual is deceased. This is a departure from ELECT's previous policy that obituaries could not be used to determine if an individual should be removed from the voter rolls. On April 3 staff began matching obituaries with undeliverable mail returned by relatives of deceased voters. To date, 150 deceased voters have been removed from the voter list.

Mr. Spicer noted that on April 6, 2023, the Attorney General issued a Certification of No Objection for all precinct and polling place changes approved by the Board of Supervisors on March 7, 2023. These changes have been implemented in VERIS, and notifications will be sent to all affected voters.

Mr. Spicer reported that HB 1948 as passed by the Senate and House removed the witness signature requirement on absentee ballot envelopes and replaced it with the last four digits of the voter's Social Security number and their full date of birth. It also allowed a voter to provide their assigned voter registration unique identifier in place of the last four digits of their Social Security number. On March 27, the governor amended the bill to only require the birth year instead of the full date of birth and to only permit individuals who do not have a social security number to use their unique identifier assigned when they registered to vote. (In Fairfax County, approximately sixty (60) voters do not have a Social Security number). The amended bill will be considered by the legislature when they reconvene on April 12.

Mr. Spicer stated that the Democratic Party primary election on June 20, 2023, will include county-wide races for Chairman of the Board of Supervisors, Sheriff, and Commonwealth's Attorney and contests in several districts for state Senate, House of Delegates, and Board of Supervisors. Mr. Spicer explained that although the deadline for candidate filing was April 6, 2023, on April 11, 2023, the State Board of Elections (SBE) voted to extend the deadline ten days for candidates to submit certain paperwork, specifically the Certificate of Candidate Qualification and the Statement of Economic Interest. As a result of the extended deadline for paperwork filing, the dates of Logistics and Accuracy (L&A) provided in the General Registrar's report (page 6) will be adjusted. Ms. Hanley added that this statutorily permitted extended deadline does not allow "new" candidates to file; it only gives additional time for the two specific items of paperwork that may have been mailed and postmarked by the deadline to be received. Ms. Hanley also commented that when so many different types of candidates are on the ballot, it is confusing for them to determine where their paperwork must be filed. Mr. Shapiro asked if the Office website posts instructions for candidate filing. Ms. Hanley responded that ELECT's website provides Candidate Bulletins for each office, however, she opined that the bulletins should provide clearer instructions.

Mr. Spicer reported that as of April 10, 38,360 absentee ballot applications for the June Democratic primary, including 37,265 permanent applications, 1,054 overseas applications, and 41 one-time applications have been received. Mr. Henzel asked if the overseas applications were mostly military. Ms. Jones explained that UOCAVA (Uniformed and Overseas Citizens Act) includes military and their eligible family members, as well as U.S. citizens residing outside the United States. All of these individuals will receive an emailed ballot.

Mr. Spicer stated that the early voting locations will be staffed with six to eight election officers, with the larger number during the final week. Because it is a Democratic primary, the chief and assistant chief officers will represent the Democratic Party; the election officers will be a mix of Democratic and unaffiliated officers. A small number of language officers, who are assigned without regard to party affiliation, may represent the Republican Party.

In person absentee/early voting will be offered in sixteen (16) locations:

Each check-in station at the early voting locations will be linked to its own ballot-ondemand printer, eliminating the need for a separate ballot officer. The Chief Officer will also have a ballot-on-demand printer for curbside and provisional voters. There will be no preprinted paper ballots at the early voting locations.

Under the Resource Allocation for the June primary elections, Mr. Spicer explained that each precinct will receive ballots for a minimum of 30% of registered voters. Some precincts, such as those with higher turnout in past elections or new precincts with no historical turnout information, will receive ballots for a minimum of 35% of registered voters. Each precinct will receive three to four Poll Pads, two ExpressVote ballot marking devices, and two DS200 scanners. Precincts will be assigned five to seven election officers. Ms. Hanley explained that there will be fourteen contested races for the June primary, the highest number in thirty years. Springfield District has twelve precincts and Mount Vernon has one precinct that will have five contested races on the ballot. As such, the ballot order for these thirteen precincts will be 35%.

After more than five years of distinguished service as the Election Officer Manager and the Election Operations Manager, Ravi Udeshi was hired as Election Manager effective April 8, 2023. Alina Selnick-Escobar resigned as Election Officer Training and Operations Coordinator effective April 21 to pursue other opportunities. This position, as well as Election Officer Manager, will be advertised within the next several weeks.

Mr. Spicer updated the new guidance regarding the release of the Cast Vote Records (CVR). CVR represent the raw data for all votes on election flash drives that are electronically loaded into the election management system. Hand counted ballots can be manually entered into the election management system, but they will not be reflected as CVR. CVR are reflected in random order and cannot be directly linked to a voter. In response to the change, Fairfax County has released CVR for the 2020, 2021, and 2022 general elections in response to Virginia Freedom of Information Act (VFOIA) requests. The VFOIA requests have included information about the election management system, election results reporting, and cast vote records to explain the process and the relationship of cast vote records to election results. Mr. Henzel

welcomed this development, and in the future, he asked if the CVR will reflect the actual votes cast. Mr. Spicer explained that UOCAVA ballots cannot be scanned electronically and must be hand-counted. These numbers will not be reflected in the CVR.

Mr. Spicer reported that on March 13, 2023, the Office informed ELECT that the turnout statistics posted in their official results for the November 2022 General Election and January 2023 Special Election appear to be incomplete because they did not account for all Same Day Registration (SDR) provisional ballots. ELECT deployed a VERIS fix on March 21, 2023, to "ensure SDR provisional counts are included on the Turnout Statistics page on the Election Night Reporting website." ELECT clarified that the turnout statistics reporting fix will not, however, apply retroactively to previously posted election results. Mr. Shapiro asked if ELECT agreed that Fairfax County's numbers were correct. Ms. Jones responded that Fairfax County's website accurately incorporates the SDR provisionals. She explained that all SDR provisional information, as well as regular provisional information, was entered into VERIS. Unfortunately, VERIS did not include a query to pull the SDR provisional information into the total turnout numbers. Mr. Henzel asked if ELECT's website explains the discrepancy. Ms. Jones answered that there is no disclaimer on ELECT's website. Mr. Henzel expressed his disappointment that ELECT did not get this basic problem corrected, especially at a time with elevated interest in reinforcing the public's confidence in elections. Mr. Henzel moved that the General Registrar contact ELECT and inform them that the Board requested a statement be added to ELECT's website explaining the discrepancy between their turnout numbers and Fairfax County's turnout numbers. Mr. Shapiro offered a friendly amendment that Fairfax County's website also includes a disclaimer as to why the reported turnout differs from ELECT's reported turnout. This amendment was accepted, and the motion passed by a vote of 3-0.

Under the Vice Chairman's report, Mr. Shapiro reported that he reviewed the security camera coverage of the Government Center absentee ballot dropbox. While not revealing operational details, Mr. Shapiro was satisfied that the dropbox is adequately surveilled and complies with ELECT's guidelines. Mr. Shapiro moved that the General Registrar ask the Facilities Management Department to trim obstructing branches to allow for greater coverage. The motion passed by a vote of 3-0. Mr. Shapiro expressed his appreciation to the Security Office for making time for the review and the explanation of the security footage.

Under the Secretary's report, Mr. Henzel attended the Virginia Electoral Board Association's (VEBA) annual meeting in March. He was not impressed by the way VEBA handled their internal governance. He said they attempted to postpone the election of their officers. He asked the Clerk to inform the Board of the amount of VEBA annual dues and to remind the Board several weeks before the annual payment is due.

Under the Chairman's report, Ms. Hanley explained that she represents the ten largest jurisdictions on the VEBA Executive Board. In the discussion at the annual conference with the 'Big Ten', she explained that all have trouble certifying the November elections on the Tuesday after the election. All ten localities agreed that VEBA's Executive Board should support 2024 legislation that extends the certification of the November election to the Friday following the Friday after the election. She also explained that the Covid pandemic caused VEBA to postpone elections and extend the terms of the Executive Board.

Under Public Comments, Ms. Mobley asked a question about contractor's requirements for the voting equipment. Ms. Hanley replied that the Board will follow up. Ms. Brim asked if given Mr. Udeshi's promotion, who will the point of contact be for training questions about election officers. Mr. Udeshi asked that all questions be directed to him. Ms. Bayer asked if the election can be certified without counting UOCAVA ballots. Ms. Hanley responded that the deadline for UOCAVA ballots is the same as all postmarked absentee ballots which is noon on the Friday after the election. These ballots are counted and included in the results.

Ms. Hanley moved that the Board go into Closed Session, pursuant to Virginia Code Section 2.2-3711(A)(1) to discuss personnel matters, as permitted by Va. Code § 2.23711(A)(1), specifically, the annual review of the General Registrar as required by Va. Code § 24.2-109.1. Without objection, and by a vote of 3-0, the Board entered a Closed Session at 4:45 p.m.

At 4:57 p.m. the Board concluded the Closed Session. Chairman Hanley read the following statement:

"In accordance with *Virginia Code* § 2.2-3712(D), I am asking the Secretary of the Electoral Board to conduct a roll call vote to certify that to the best of each member's knowledge that (i) only public business matters lawfully exempted from open meeting requirements of the Virginia Freedom of Information Act were conducted in the closed meeting and (ii) only such public business as was identified in the motion for the closed meeting, by which the closed meeting was convened, was heard, discussed or considered in the closed meeting of the Electoral Board. That roll call vote shall be recorded and included in the minutes of the Electoral Board."

Secretary Henzel then called the roll for the vote on the above statement:

### **Emergency Relocation of the Polling Place for #426 Greenspring Precinct**

On April 24, 2023, Erickson Senior Living (Erickson) informed the Office of Elections that the polling place located at the Greenspring Conference Center, 7430 Spring Village Drive (Hunter's Crossing) was under renovation and not available for use as the polling place for #426 Greenspring precinct for the primary elections on June 20, 2023. Erickson suggested a temporary relocation at 7410 Spring Village Drive (Village Square). Because this notification was received within 60 days of the June 20, 2023, date for primary elections and does not allow adequate time for relocation under Virginia Code § 24.2-129, the polling place may be temporarily relocated under guidance found in Virginia Code §24.2-310(D). This provision allows the General Registrar or the Electoral Board to provide an alternative polling place when an "emergency makes a polling place unusable or inaccessible."

If this emergency polling place relocation is approved by the Electoral Board, staff will notify the Virginia Department of Elections in Richmond (ELECT), Franconia District Supervisor Rodney Lusk, and the candidates on the Greenspring precinct ballot about the emergency relocation. Staff will also provide notice to the Greenspring voters at least 15 days before the June 20 primary elections. Greenspring will also publicize this change within the community and increase shuttle service to the new polling place on the day of the primary elections.

### Removal of Deceased Voters from Fairfax County Voter List

ELECT recently examined its data sharing relationship with the Virginia Department of Health (VDH). ELECT requested a review of all VDH death records going back to 1960. VDH discovered death records that had not been previously shared with ELECT. After additional data analysis by ELECT staff, 18,990 records of registered voters were identified including 1,669 deceased voters in Fairfax County. On April 19, 2023, ELECT sent the records for these deceased voters through VERIS to local General Registrars for processing. We promptly removed the 1,669 deceased voters from our voter list.

### Contests and Candidates for the June 2023 Democratic Party Primary Election

I am providing the Electoral Board with a printout reflecting the contests and candidates that will appear on our ballots for the June 2023 Democratic Party Primary Election.

### Change in Dates for Logic and Accuracy Testing

As a result of the 10-day extension that ELECT gave candidates for the filing deadline we did not receive ballot information for candidates and contests from ELECT until Tuesday, April 25. Due to this and other complications associated with the ballots, we delayed the Logic and Accuracy testing for Poll Pads and voting equipment for the Early Voting locations until May 1 and May 2. We notified the Fairfax County Democratic Committee about this change.



#### Request to Trim Tree Branches Partially Obstructing Drop Box Camera

As requested by the Electoral Board during the April 12, 2023, Electoral Board meeting, staff sent a request to the Facilities Management Department (FMD) to trim the tree branches that are partially obstructing one of the two cameras that monitors the permanent drop box at the main Government Center complex. Staff will follow-up with FMD to ensure that the tree branches are trimmed, and that the camera's view of the drop box is not obstructed.

#### **Information Concerning Provisional Turnout Statistics**

In my April 11, 2023, report to the Electoral Board, I noted that on March 13, we informed ELECT that the turnout statistics posted in their official results for the November 2022 General Election and January 2023 Special Election appear to be incomplete in that they exclude all Same Day Registration (SDR) provisional ballots.

ELECT indicated that they were going to correct this error with a VERIS fix that was to be deployed on March 21 indicating that this "will ensure SDR provisional counts are included on the Turnout Statistics page on the Election Night Reporting website." ELECT clarified that the turnout statistics reporting fix would not apply, retroactively, to previously posted election results.

As requested by the Electoral Board during the April 12 Board Meeting, I contacted ELECT on April 13 and asked them to correct their provisional turnout statistics for November 2022 and January 2023 to include SDR provisional ballots. ELECT staff responded by indicating that they were in the process of making those corrections. As of April 28, ELECT had not made those corrections.

As requested by the Electoral Board during the April 12 Electoral Board meeting, we posted the following note on the election results page on our website:
