MINUTES Fairfax County Electoral Board August 7, 2023

The Fairfax County Electoral Board (Board) met on Monday, August 7, 2023, in Conference Room 315 at the Fairfax County Government Center located at 12000 Government Center Parkway, Fairfax. Chairman Hon. Katherine K. Hanley; Vice Chairman Jeffrey K. Shapiro; Secretary Amb. (ret.) Christopher P. Henzel; General Registrar Eric L. Spicer; Deputy Director Cheryl Jones; and Clerk to the Electoral Board Beth Dixon Methfessel were present.

Ms. Hanley called the meeting to order at 4:00 p.m. and introduced the Board. Mr. Henzel moved approval of the agenda, and the motion passed by a vote of 3-0. Mr. Henzel moved to adopt the Draft Minutes of the Board meetings held on June 14, 2023, and June 21, 2023. By a vote of 3-0, the Minutes of the Board meetings held on June 14, 2023, and June 21, 2023, were adopted.

Mr. Henzel made a motion to appoint of 62 election officers (EO) (30 Democrats, 9 Republicans, and 23 Unaffiliated) for a term ending February 28, 2025. The motion passed by a vote of 3-0.

Under the General Registrar's (GR) report dated May 1, 2023 (attached and made a part of this record), Mr. Spicer updated the voter registration numbers since the last Electoral Board meeting:

Mr. Spicer explained that the USPS National Change of Address (NCOA) confirmation mailing is part of a list maintenance process mandated by Va. Code §24.2-428 and the National Voter Registration Act (NVRA) that is managed by the Virginia Department of Elections in Richmond (ELECT). During most years ELECT sends only the one legally required confirmation mailing. This year, ELECT sent out two confirmation mailings, February 3 and July 24, in an effort to improve the accuracy of the voter list. Prior to July 1, only voters who moved <u>outside</u> of their local jurisdiction or Virginia were automatically moved to an "Inactive" status approximately 30 days after the mailing date if no response was received back from an NCOA mailing. Beginning July 1, 2023, voters who move <u>within the jurisdiction</u> and fail to respond to the NCOA mailing will be processed in the same manner as "out of state" or "out of the jurisdiction" voters; they will now be coded as "Inactive" in VERIS.

In a further effort to improve the accuracy of the voter rolls, in September the sample ballot mailer will be sent "Return Receipt Requested." If the mailer is undeliverable, it will be returned to the Office.

Earlier this year, the General Assembly changed the statutory requirements for absentee by mail voting (Va. Code § 24.2-706). Effective July 1, absentee voters are required to provide the last four digits of their Social Security number and year of birth instead of a witness signature

when completing their "statement of voter." Due to these legislative changes, the absentee ballot return envelope will be redesigned. The new absentee envelope will continue to provide an intuitive template for absentee voters to complete their voter statement while providing for the privacy of their newly required personal information. The return envelope will allow the absentee voter submission to be processed while the ballot remains sealed in the envelope. Staff continues to work with the third-party printer/mailer to ensure that the return envelope complies with USPS guidelines and supports effective postal processing.

To establish consistency, the November 2023 early voting schedule will be the same as 2022. Three locations (Government Center, Mount Vernon, and North County) will be open starting on Friday, September 22 and they will also be open on Saturday, September 23. An additional 13 locations will open on Thursday, October 26 after which all locations will be open for 10 days in a row until November 4 including Sunday, October 29.

Training for satellite staff is scheduled for the week of September 11 and the weeks of October 9 and October 16. The satellite Chiefs and Assistant Chiefs will be prepared for Same Day Registration.

Nazila Arefi was hired as an Administrative Assistant for the HR Division on July 15. Cheryl Jones was selected as the Deputy Director of Elections. Florence Brown will assume the role of Deputy Registrar for Voter Satellite Offices. Gretchen Coleman will start on August 21 as the new Election Officer Manager.

Research is ongoing in the voting equipment and replacement project. Of the four certified vendors in Virginia that have developed or are developing voting equipment that would meet the new 2.0 standards, two vendors have agreed to attend the September Electoral Board meeting to present their 2.0 compliant equipment. The current plan is to make a decision concerning the purchase of new voting equipment by December 2023 or January 2024, work on the contract during 2024, and acquire the new equipment in early 2025. No possession of any equipment will be authorized until it has been certified under the new 2.0 standards.

Under the Secretary's report, Mr. Henzel informed the Board that the Virginia Electoral Board Association (VEBA), in cooperation with the group Informing Democracy, sent out a survey to all members. The communication conveyed that the survey was non-partisan in nature, however, Mr. Henzel indicated that he received information that the group was not non-partisan, and he did not plan to respond to the survey. He added that Informing Democracy has carried out studies in other states that resulted in identifying at least 200 electoral board members that have "anti-democratic tendencies or are threats to democracy." On the Informing Democracy website, these "threats" include "probing for vulnerability in election law or process." Mr. Henzel indicated that he plans to write the group regarding his concerns. Ms. Hanley remarked that she received the survey but since it was voluntary, did not respond to it. Mr. Shapiro said he did not receive the survey because for some reason, he is not receiving emails from VEBA.

There was no Vice Chairman's report,

Under the Chairman's report, on behalf of the Board, Ms. Hanley sent a letter to the School Board asking for a revision in the 2023-2024 school calendar to close schools for the March 5 Presidential Primary. She attended the School Board meeting in July to present the appeal in person, and the Board took the request under advisement. The Board agreed that she should follow up and emphasize the safety issue for the students and remind the School Board that 167 schools serve as polling places.

Ms. Hanley passed out an ELECT Advisory (attached and made a part of this record) that explained how the observance of the Veteran's Day holiday on Friday, November 10, will move the date to receive post-marked absentee ballots from Friday, November 10 to Monday, November 13. The deadline to certify the election by submitting completed abstracts remains Tuesday, November 14. Ms. Hanley explained that this year is further complicated by the number of contests on the ballot. Last year legislation was proposed to extend the certification

from the Tuesday following the election to the Friday following the deadline to receive postmarked absentee ballots (an additional three days). At the 2023 annual VEBA conference, VEBA leadership confirmed that this recommendation will be part of their legislative package. Ms. Hanley noted that the Board of Supervisors also supports a legislative program, and she requested Board support to ask the Board of Supervisors to endorse extending the certification deadline by three days. Mr. Henzel commented that the bill extending the deadline failed in the 2023 legislative session in part because legislators also supported shortening the deadline to receive post-marked absentee ballots. He suggested that just extending the certification deadline without moving up the deadline to receive post-marked absentee ballots will fail again in 2024. He prefers recommending that both dates be adjusted to spread out the certification timeline. Mr. Shapiro agreed with Mr. Henzel and referenced the challenges to certify on time for the June primary election with only 10% turnout. He further opined that the General Assembly has made the election process "extremely complex" over the years and that the legislature needs to change the rules to provide funding and mitigate the complexity of the election process. He indicated; however, he would support a motion to move the certification deadline for delivering the abstracts of election from 7 days to 10 days following the election. Ms. Hanley so moved, and the motion passed 2-0 with Mr. Henzel abstaining.

Under New Business, the Board acknowledged the Resource Allocation for the voter satellite offices for the November 2023 General and Special Elections (attached and made a part of this record).

Under Public Comments, Ms. Hanley reminded the public that comments are limited to three minutes. The Board may provide the information; however, an answer may be deferred if more research is required.

Ms. Bayer confirmed that an SDR specialist will be assigned to every precinct. She thanked Mr. Udeshi for providing electronic applications for election officers, including the announcements for the job openings. She asked if there would be a separate email for applications for the Central Absentee Precinct (CAP). Mr. Stewart replied that currently the CAP is adequately staffed, however, if anyone has an interest in serving in the CAP, to reach out to him directly.

Mr. Martin expressed his support for ranked choice voting (RCV) in Fairfax County after Arlington County's attempt at using this method for the June primary election. Mr. Henzel responded that RCV "unnecessarily complicates the process and detracts from the perception of transparency." Mr. Shapiro agreed and reiterated that complexity in the electoral process is a "self-inflicted wound." Ms. Hanley mentioned that the software is currently unavailable to count ranked choice ballots. She added that implementing ranked choice voting is premature in a jurisdiction the size of Fairfax County. Mr. Denk commented that ranked choice voting was used in a Republican primary and as a result, the third-place candidate prevailed. He added that he also opposes implementing RCV in a locality the size of Fairfax County.

The next Board meeting will be on Wednesday, September 27, 2023, at 4:00 p.m.

Mr. Henzel moved to adjourn. The motion was carried, and without objection, the meeting was adjourned at 4:32 p.m.

New Absentee by Mail Return Envelope

The General Assembly changed a statutory requirement for absentee by mail voting (Va. Code § 24.2-706) that removed the need for a witness signature on the "statement of absentee voter" and replaced it with a requirement for the last four digits of the voter's Social Security number and year of birth. To implement these legislative changes, we developed a new absentee ballot return envelope in collaboration with our third-party printer/mailer and the USPS and began using it with the September 22 mailing.

The new absentee return envelope features a privacy flap that covers the "statement of absentee voter" while the mailer is in transit, but, importantly, allows staff to review and process the returned envelope as efficiently as possible. Although this privacy flap is not legally required, we added this feature to protect a voter's birth year and SSN4. An image of the voter submission area and privacy flap on the new envelope is attached to this report.

Absentee by Mail Requests for November 2023 Election

As of September 22, we have received **59,611** absentee ballot applications for the November 2023 General Election. This includes **55,633** permanent applications, **1,669** applications from overseas and military voters, and **2,309** one-time applications.

Sample Ballot Mailing - Mailed by Fairfax County Office - September 2023

Sample ballot brochures will be mailed this week to all active voters in Fairfax County. It includes an image of the voter's precinct-specific ballot, information on the three ways they may vote, the voter's polling place and precinct, and in-person early voting locations and schedules.

In-Person Absentee Voting

On September 22, in-person absentee voting for the November 2023 Election began at the Government Center, Mount Vernon Governmental Center, and North County Governmental Center. We had a total of 757 voters at these three locations on September 22 and 340 voters on September 23.

An additional 13 locations will open on Thursday, October 26. Then all locations will be open for 10 days in a row until November 4, including on Sunday, October 29.



Resource Allocation for Precinct Polling Places

For each election, we develop a resource allocation plan and order ballots based on comparable elections. In November 2019, the average turnout at precinct polling places was 40%. In November 2021 and November 2022, the average turnout at precinct polling places was about 37%.

For this election, each precinct will receive ballots for at least 60% of active voters. We will order ballots for 65% to 80% of active voters for the precincts that had the highest in-person turnout in past elections and for new precincts created as a result of redistricting.

Each precinct will receive three to five Poll Pads, two ExpressVote ballot marking devices, and two DS200 ballot scanners.

Each precinct will be assigned seven to twelve total election officers, including one SDR specialist officer to help the chief process same day registration voters.

Election Officers

Election Officer Assignments

In accordance with the Code of Virginia and Electoral Board policy, we have assigned and confirmed Republican officers as chiefs for more than 250 precincts this election. Due to extensive staff efforts, we have also identified a pool of about 100 more Republican officers willing to serve as a chief or reserve chief this election. This means we have more than enough individuals to ensure we have a Republican chief in all 265 precincts, as well as about 35 who are ready to step in should a chief cancel anywhere in the county.

We have assigned more than 2,000 officers and are currently in the process of notifying and confirming assignments. More than 1,400 officers have confirmed their assignment. We expect to complete the assignment and confirmation process by mid-October.

We launched a new Election Officer Portal website to provide a single location for election officers to submit and update their availability, review and accept their precinct assignment, and enroll in and complete training.

Election Officer Training

We launched updated versions of our Election Officer Basics, Chief and Assistant Chief Basics, and SDR Basics online training classes in mid-September. These are currently available on our election officer training website (https://training.electionofficers.com).

In addition, we scheduled numerous in-person classes in late September and through October.

- Equipment practice sessions, which are mandatory for first-time election officers. These are open to other election officers as well.
- Numerous Chief Workshops, which will give first-time chief officers hands-on practice with tasks and forms they can expect to complete on Election Day.
- SDR Workshops, during which we will give first-time chiefs and SDR Specialists hands-on practice with the same day registration process.

As always, we will conduct our mandatory training the week before Election Day for chief and assistant chief officers to go over procedural and legal updates for the election.

Office Personnel

Florence Brown was appointed satellite manager effective July 15. Gretchen Colemen was hired as election officer manager effective August 21, and Abigale Peters was promoted to the election officer specialist position effective September 23. We are recruiting a training specialist for the Election Administration Division, a GIS analyst for the IT Division, and an administrative assistant for the Absentee Division.



FOIA

We have received six VFOIA requests and one NVRA request since the August Board meeting. We received a total of 58 VFOIA requests between January 1 and September 22.

Voting Equipment and Replacement Project

As we noted previously, we are in the process of planning for the replacement of the county's voting equipment with new machines that will meet the new federal VVSG 2.0 security standards. We contacted the four voting equipment companies that are certified in Virginia to find the best solution. Only Hart InterCivic and ES&S have developed or are developing machines that will meet the new 2.0 standards within our purchasing time frame. During the September 27 Board Meeting, HART and ES&S will provide information on their voting equipment designed to meet these standards.

On September 14th, I was served with a lawsuit that questioned the validity of signatures on a candidate petition. The lawsuit, filed by three voters in Fairfax County and the Fairfax County Republican Party, sought to disqualify six signatures without a date on the candidate petition for Ms. St. John Cunning, a candidate for School Board in the Franconia District.

This matter was presented at a hearing in the Fairfax County Circuit Court on September 20th. The judge dismissed the case and ruled that I had discretion, in my position as General Registrar, to determine that the six signatures in question were valid and that the missing dates were not a material omission.

We began voting on September 22 with ballots that were approved by ELECT on September 7th that included Ms. St. John-Cunning as a candidate for School Board in the Franconia District.
