## **OVERVIEW**

The record-breaking rainstorm on the morning of Monday, July 8, 2019 was felt countywide as we experienced flooded roads, homes, businesses, public facilities and motorists stranded in their vehicles.

The Board of Supervisors declared a local state of emergency for the rain event. Residents are encouraged to track their costs in case the county becomes eligible for federal assistance.

## IF YOU SUSTAINED DAMAGE

- 1. Assess and document the damage
- **2.** Call your insurance company
- File your report online through the Disaster Damage Database at www.fairfaxcounty.gov/disasterreport

#### SMALL BUSINESS ADMINISTRATION

If the county becomes eligible for federal assistance, impacted residents will have to apply directly to the SBA.

The U.S. Small Business Administration (SBA) offers affordable financial help to homeowners and renters in declared disaster areas. Help is available in the form of low-interest, long-term loans for losses not fully covered by insurance or other means. You may borrow up to \$200,000 to repair or replace your primary home to its pre-disaster condition. But unless required by building code, you cannot use the loan to upgrade or add on to the home.

In some cases, SBA may be able to refinance all or part of a previous mortgage (not to exceed \$200,000). To do so, we must find that you meet the conditions below:

- You don't have credit available elsewhere.
- You have a substantially damaged property.
- You intend to repair or replace the damaged property.

SBA considers refinancing when processing each application. We may also be able to increase the loan up to 20 percent of the confirmed physical losses (not to exceed \$200,000).

You could use the loan increase to make improvements that may help protect your home from future disasters. This could include improvements like retaining walls, seawalls, sump pumps, safe rooms, and storm shelters.

Second homes and vacation properties are not eligible. Qualified rental properties may qualify for a business disaster loan. You may also be able to borrow up to \$40,000 to replace damaged or destroyed personal property. This may include the items such as clothing, furniture, appliances, cars, and other personal property; not real estate or part of the actual structure

You may not use the loan to replace very expensive or rare and unique items. This may include items such as antiques, collections, pleasure boats, and recreational vehicles.

Other terms and conditions may apply.

## **IMPORTANT INFORMATION**

The Board has approved temporarily waiving all fees related to building permits for all repairs to correct damages arising from and directly associated with the July 8. 2019, weather event.

This temporary waiver of fees, for a period not to exceed 90 days from the date of the declaration of local emergency, does not remove the requirement for adherence to all federal, state, and local building codes. This buffer is meant to give those seeking repairs for damages the time to work with insurance companies.
