- David Jonas called the meeting to order at 7:03pm
- David Jonas read the electronic meeting script as authorized by FOIA and performed roll call establishing that each member can hear each other.

#### **Approval of Minutes:**

## **Director's Announcements**

- Michael Beckets and Melanie Fenwick presented.
- Guidelines for Electronic Meeting and Remote Participation:
  - Effective July 1, 2021, remote participation will be allowed when:
    - Sick
    - Family member needs care
  - As long as Fairfax County's local state of emergency is in place ASSB can continue to meet electronically.
  - A member can be remote 25% a year.
  - Should ASSB return to in person meetings?
    - Take it month by month but remain remote for now.
- ASSB Member Orientation:
  - Review orientation packet
  - Orientations would be under two hours.
  - What would be helpful?
    - Know what the role of the ASSB is.
    - Know what the role of each member is.
    - Knowing what the time commitment
  - $\circ$  DFS to offer an orientation refresher to current members.
    - DFS will get together some dates and present them at the next meeting.

### Update from Children, Youth, and Family:

- Kamonya Omatete, Julie Brown, and Sandi Slappey Brown presented.
- Safe & Connected Integration Project
  - Purpose: Fully implement the Safe & Connected Practice model throughout CYF
  - Method: Engage Accenture to help us identify strengths and gaps and develop a roadmap to guide this work
  - o Status: Roadmap is complete; entering Implementation Phase
- Child Welfare Institute Redesign
  - Purpose: Strengthen professional development for new hires, current staff, and supervisors
  - Method: Engage Butler Institute from Denver University to help us assess needs and develop curricula, simulations, transfer of learning activities, supervision framework, and coaching plans
  - Status: Work began in late April to set up project structure, adjust workplan, provide foundation and conduct needs assessment
- Equity
  - Purpose: Ensure that an equity-informed approach anchors every interaction with peers and every intervention with families as well as the delivery of services to the community

- Method: Integrate and Equity Plan into all major initiatives, including the Safe & Connected Integration Project and CWI Redesign. Use data where available to inform actions.
- Status: Charter approved in May; work is beginning on equity planning for Safe & Connected Integration Project.
- IT projects
  - FROST: Database to help maintain compliance and track and report on work with children in foster care, resource families, and adoptive families. Partial launch in Feb. 2021; full launch expected summer 2021.
  - OpenText: Design new electronic case file system to replace Documentum. Project began in early May and will last 8-12 months.
- Other significant efforts:
  - PIP: Participate in the statewide Program Improvement Pan coming out of the last federal Child and Family Services Review. Helped VDSS achieve 9 out of 10 outcomes.
  - Strategic Plan: Sunset current plan and develop new two-year plan focusing on Safe & Connected practice, professional development objectives, and strengthened focus on engaging relatives.
  - Timely Adoption: Increase precent of children adopted from foster care within 24 months. Study factors contributing to this. Already seen improvement from 12% to 39%.

  - Race of Children in Foster Care
    - Hispanic: 31%
    - African American/Black: 23%

    - White: 18%
    - Asian: 6%
    - Middle Eastern: 3%
    - American Indian: 0%
  - 189 total children in foster care. 49% male and 51% female.
  - Age of Clients in Foster Care
    - <2:25%
    - **3-5**: 11%
    - 6-8: 6%
    - 9-11:10%
    - 12-14: 8%
    - **15-17: 25%**
    - **18-20:** 15%
  - Reasons for Leaving Foster Care (108 children)
    - Return home: 24%
    - Adoption: 40%

- Custody transferred to relatives: 11%
- Age out: 23%
- Other: 2%
- Steps to Becoming a Foster Parent:
  - Information meeting
  - Participant is still interested AND matches needs of the Foster Care and Adoption Program
  - Initial home visit
  - Participant is still interested AND meets requirements.
  - Attends PRIDE Training (5 sessions in person and 4 sessions online: 15 hours in person and 44 hours online)
  - Home study/interviews/home visit
  - Approval and certification
  - Await placement.
- New Generation PRIDE Pre-service Training for Resource Parents:
  - Duration: Approximately 44 hours online and 15 hours in classroom.
  - Trainers: A Fairfax County Department of Family Services Social Services Specialist and a Resource Parent.
  - $\circ$   $\,$  What will you learn:
    - The challenges and rewards of being a resource family.
    - The skills necessary to meet the needs of children in foster care.
  - Visuals:
    - Videos depicting real life situations to help you better understand what children and their families are experiencing.
    - A panel made up of individuals with various experiences in the Child Welfare System: young adults who were in foster care as children, adults who were adopted, current foster parents, and children of current foster parents.
  - Our goals:
    - To deepen your understanding of how you manage trauma, change, attachment, and children with self-esteem issues.
    - To develop the skills necessary to:
      - Protect and nurture children.
      - Meet their developmental needs and address their developmental delays.
      - Support the relationships between children and their birth families.
      - Connect children to safe and nurturing relationships intended to last a lifetime.
      - Work as a member of a professional team.
