Ashley Reynolds Marshall, M.P.A, J.D., Chair for the Virginia Council on Women, serves as the first Deputy City Manager for Racial Equity, Diversity, and Inclusion for the City of Charlottesville, Virginia, Her role in Charlottesville will focus on leading efforts to cultivate an environment that values and demonstrates the City's commitment to racial equity, diversity, and inclusion; while also advocating for and developing strategies to promote shared organizational responsibilities for those principles that foster equity. In addition she will work to provide complementary leadership for the Office of Human Rights, Department of Social Services, Department of Human Services, and the Police Civilian Review Board.

Marshall, a native of Roanoke, Virginia, holds a B.A in Psychology from Hollins University, a J.D from the College of William and Mary School of Law, and an M.P.A. from Virginia Tech. Marshall is also currently pursuing a Ph.D. at the Center for Public Administration and Policy at Virginia Tech where her dissertation is focused on Collaborative Governance, Corporate Social Responsibility and Collective Impact/Collaborative Programming. She is a member of the 2013 class of the Sorenson Institute Political Leaders Program at the University of Virginia and a member of the 2014 class of Emerge Virginia.

Marshall currently serves as a member of the Virginia Advisory Committee on Sexual and Domestic Violence, and a Board member for the Virginia Rural Health Association. In her spare time, Ashley enjoys exercise, reading, and spending time with her husband Samson Marshall and their senior rescue beagle Charlie.



Solitaire Carroll is an Organizational Change Management Consultant with a BSc in Psychology, industry certifications for organizational change management (ITIL, BRMP, PMI, SAFe), and 10 years of public and private organization change management development and training experience. The WB's mission is to develop policies and standards and conduct inquiries to safeguard the interests of working women; advocate for their equality and economic security for themselves and their families; and promote quality work environments.

As the career Deputy Director, Joan is responsible for overall policy, programs and operations of the Bureau and ensures that policies and budget are aligned with the mission and direction.

Prior to joining the Women's Bureau, Ms. Harrigan-Farrelly worked at the U.S. Environmental Protection Agency (EPA) for 14 years and has had the unique opportunity to work in various leadership positions across the Agency. She has served as the Director of the Antimicrobials Division in the Office of Pesticide Programs; as the Director, Resources Management Division in the Superfund Program; as Branch Chief in the Office of Ground Water and Drinking Water; and as Senior Advisor in EPA's Office of Homeland Security.

Prior to her service with EPA, Ms. Harrigan-Farrelly worked at the United States Agency for International Development as one of the Women in Development Senior Fellows in the Policy Bureau, focusing on gender and environmental issues.

Ms. Harrigan-Farrelly holds a Bachelor's degree in Social Work from Rutgers University and a Master's degree in Urban Planning and Public Administration from New York University.

**Carol Jenkins is President and CEO of the ERA Coalition and the Fund for Women's Equality**, sister organizations dedicated to the adoption of the Equal Rights Amendment. A board member since its inception in 2014, she joined the leadership team in December of 2018.

Previously, Carol Jenkins was founding president of The Women's Media Center, a national nonprofit organization created to increase coverage and participation of women in media. As president, she conceived the Progressive Women's Voices program to provide media training for women and girls, and she expanded SheSource, the largest portfolio of women experts in the country.

As former chair and current board member of Amref Health Africa USA, an arm of the largest health NGO in Africa, Ms. Jenkins is engaged in efforts to support health programs for African women and girls. She also serves on the boards of several feminist leadership organizations as well as groups supporting the arts, excellence in journalism, and international animal rights.

Carol Jenkins earned a B.A. from Boston University and an M.A. from New York University. Both universities honored her as a Distinguished Alumna. She holds honorary doctorates from the College of New Rochelle and Marymount Manhattan College. She was a 2017 recipient of the Sackler First Award, given to women who are pioneers in their fields. As a pioneering African American television reporter, Jenkins was an anchor and correspondent for WNBC TV in New York for nearly 25 years. She hosted Carol Jenkins Live, her own daily talk show, on WNYW-TV. Early in her career she co-hosted one of the first daily public affairs programs in New York City, Straight Talk on WOR-TV; and co-hosted Positively Black for WNBC TV, one of the earliest television programs dedicated to Black issues in the United States.

Ms. Jenkins is also an author, the three-time NY Emmy-nominated host of Black America, on CUNY TV, the executive producer, writer and documentary correspondent of an award-winning film, a podcast host, and co-anchor of CUNY TV's live election night coverage.



Ellie Smeal, co-founder and President of The Feminist Majority Foundation, a former president of the National Organization for Women, and publisher of Ms. Magazine, Eleanor Smeal's life and work has been dedicated to the achievement of women's equality and human rights. Known as a political analyst, strategist, and grassroots organizer, Ms. Smeal has played a pivotal role in defining the debate, developing the strategies, and charting the direction of the modern-day women's movement. In her more than 40 years as a leader in the United States' women's movement, she has changed the landscape of women's involvement in national life and culture.

One of the modern architects of the drive for women's equality, Ms. Smeal's 1984 book, How and Why Women Will Elect the Next President, predicted that women's votes would be decisive in presidential politics. In this writing she was the first to identify the "gender gap", the difference in the way women and men vote, and popularized its usage in election and polling analyses to enhance women's voting clout. Her leading role in state and national campaigns for women's rights legislation, including the Equal Rights Amendment, helped reshape the contours of U.S. politics as politicians could no longer ignore the voices of women, forcing their inclusion as part of the national political discourse. Her efforts led to women's organizations shifting the strategy of targeting only a few select races for women candidates to a philosophy of recruiting women to run for as many elected offices as possible. Recognizing the power of the internet, she pioneered its use as an organizing and research tool by launching the Feminist Majority Foundation Online in 1995.

Ms. Smeal serves on a number of boards, including the National Council for Research on Women, the National Organization for Women, and the Leadership Circle of CEDAW (the Convention on the Elimination of all Forms of Discrimination Against Women). Smeal and her achievements were honored as an inductee into the National Women's Hall of Fame in 2015.



Lisa Sales, ERA Advisory Council & Fairfax County Commission for Women; Lisa Sales has been a management and strategy consultant with Booz Allen Hamilton's Global Defense Group for a decade. Recently, she was awarded the Fairfax County, Virginia Citizen of the Year in 2020 by the Federation of Citizens Associations. Ms. Sales was elected to be a Delegate to the Democratic National Convention in 2016 on behalf of President Joe Biden. She served on the Biden for President Domestic Policy Team, Women & Families Committee, where she wrote or contributed to numerous policy papers on Domestic and Sexual Violence and the Equal Rights Amendment for the transition team.

Ms. Sales is the Chairwoman of the Fairfax County Commission for Women (CFW) and the Mount Vernon District Commissioner. CFW advises the County Board of Supervisors on policies and initiatives to promote gender equality, eliminate violence against women, and honor women and girls in Fairfax County. Ms. Sales also sits on the Fairfax County Council to End Domestic Violence. She has been active with the Northern Virginia Regional Commission facilitating military-community partnerships and was a task force member of Supervisor Dan Storck's Moving On Safe Haven Project to ensure emergency domestic violence shelters are made available to those in need along the Route 1 corridor. She is a member of the Public Policy Committee for the statewide Virginia Sexual and Domestic Violence Action Alliance, and on the Board of Directors at Good Shepherd Housing and Family Services seeking to provide more affordable housing in the region.

Ms. Sales is, herself, a sexual assault survivor who endured a seven-year protracted court battle against her perpetrator. Recognizing there is a link between the lack of equality for women and the sexual violence perpetrated against them propelled her onto the leadership team of the VAratifyERA campaign. She is also an advocate for strengthening laws on protective orders by providing greater protections to survivors of domestic and sexual violence, particularly when it comes to firearms surrender.

Ms. Sales is an Advisory Council Member for the ERA Coalition and is working with the Feminist Majority to ensure the Equal Rights Amendment is enshrined in the U.S. Constitution. She is also an active member of the League of Women Voters – Fairfax Area.



**Glynda C. Carr, Political strategist and the Co-founder of Higher Heights for America** and Higher Heights Leadership Fund, the leading national organizations dedicated to building Black women's collective political power from the voting booth to elected office. She is the co-creator of the #BlackWomenLead movement which is creating the environment for Black women to vote, run and lead.

Glynda is the former Executive Director of Education Voters of New York, a leading independent voice for school reform in the state. Prior to Education Voters, she was Chief of Staff to New York State Senator Kevin Parker (Brooklyn) where she also served as campaign manager for two of his successful re-election campaigns.

Glynda has also held senior management positions with key national organizations including: the Thurgood Marshall Scholarship Fund and Big Brothers Big Sisters of America.

A sought-after speaker and trainer, she has also contributed to TheRoot.com, Ebony.com, and the Huffington Post. In 2018, she appeared on "Essence" magazine's second annual Woke 100 list, saluting female changemakers.



**Kimberly Peeler-Allen** has been working at the intersection of race, gender and politics forover 20 years. Kimberly is the Co-founder of Higher Heights for America and Higher Heights Leadership Fund, the leading national organization dedicated to building Black women's collective political power from the voting booth to elected office. She is the co-creator of the #BlackWomenLead movement which is creating the environment for Black women to vote, run and lead.

Kimberly is currently a Visiting Practitioner at the Center for American Women and Politics (CAWP) at Rutgers University where she served as an advisor on

CAWP's Election 2020 analysis, and guest lectures in various graduate and undergraduate courses.

Kimberly serves as Board Chair of the ERA Coalition, Co-Chair of Higher Heights for America PAC and is a board member of the Fund for Women's Equity and NARAL Pro-Choice America Foundation.

17-year-old Author, Speaker, Founder & President of the So Positive Initiative, CEO & Founder of So Positive, LLC., and The SWEY Corporation, and Host & Founder of the Gen Z Speaks podcast. From her second book, "Creating Confidence," Alana founded the So Positive Initiative (SPI). SPI mentors 5th grade students to help them understand and develop their self-confidence as they matriculate into middle school, while also spreading their impact through tangible means through the SPI 12-part book series featuring the programs highlighted and most popular lessons. Along with her community driven initiatives, Alana is a motivational speaker, and has spoken at venues including the largest women's business conference in the state of Virginia. Her entrepreneurial spirit and drive has allowed her to create the first natural sports drink made by Gen Z for Gen Z out of her need for a product like this as a prediabetic when she was 8-years-old. Starting with only five vehicles in 1990, Bouweiri diversified the business and developed Reston Limousine into a \$28 million company today with 250 vehicles from sedans to coach buses.

Kristina also is the founder of the monthly networking program zSterling Women and co-founder of the annual Virginia Women's Business Conference – two programs that have helped hundreds of women entrepreneurs and executives achieve their professional goals. An active business community leader, Kristina has served or currently serves on boards around the DC region and beyond, including Enterprising Women magazine DC Chamber of Commerce, Leadership Greater Washington, Northern Virginia Community College, Inova Loudoun Hospital Foundation, and Loudoun CEO Cabinet, among others. She also is a member of the Dean's Advisory Council at George Mason University's School of Business, where she helped launch a Women in Business Initiative program to support students, alumni and other businesswomen.

Her recognitions include Washington Business Journal's Power 100 and Top Women-Owned Businesses in Washington DC, DC Chamber of Commerce Business Leader of the Year, and International Women's Entrepreneurial Challenge Award.

Bria Gadsden, M.S. ,Founder "Love your Menses"


