## 2023-24 Needs Assessment and Review of Priorities

In May 2021, the CAAB finalized their FY 23-24 CSBG Funding Priorities much earlier than in previous years to ensure they would be included in the FY 23-24 CCFP RFP. Staff would like the CAAB to review the FY 23-24 Priorities along with the most recent needs assessment data, to ensure there is still alignment between its priorities and current community needs.
