- Fahima Amiri will assume duties as the Administrative Assistant II for the Nutrition Program effective Wednesday, May 4, 2022.
- Alison Banks, MSW, will fill the vacant Social Services Specialist II position in the Nutrition Unit on Monday, May 23, 2022.
- The Nutrition Unit continues to provide MOW services to eligible adults over age 60 or adults over age 18 with disabilities who elect to self-quarantine due to the pandemic.

### Nutrition: Congregate Meals

- The Congregate Nutrition Program Coordinator has been monitoring Adult Day Health Center (ADHC) meals sites in preparation for the ADHC transition from the Health Department to the Department of Neighborhood and Community Services in July 2022.
- The RFP process for Braddock Glen Assisted Living is complete and a contract is expected to be awarded in early May, with a contract start date of July 1, 2022.
- The Congregate Nutrition Program continues to provide nutritious meals and opportunities for socialization and recreation to county residents aged 60 and over at Fairfax County Senior Centers and Adult Day Health Centers.

#### Caregiver and Support Services

- On Friday, April 8, 2022, *Health & Wellness Workshop: Yoga and Meditation for Stress Reduction* was held. **53** people attended the webinar.
- On Wednesday, April 20, 2022, *Parkinson's Disease: Diagnosis, Treatment, and Interventions.* webinar was held. **71** people attended the webinar.
- On Friday, April 29, 2022, *Health & Wellness Workshop: Mindfulness in the Kitchen* was held. **45** people attended the webinar.
- New Panel Conversation, *Faith & Spirituality in the Caregiving Journey*, has been scheduled for Friday, May 27 from 2:00p.m. to 3:00p.m.
- During the month of **March 8** Caregiver Alert Notifications were sent via email, text messages, and voice communication methods. The notifications contained information on a Caregiver Webinar, Free Chronic Pain Self-Management Program, Caregiver Stroke Support Group, Walk with Ease Program, Caring for You Caring for Me class, Consultations for Caregivers, Health and Wellness programs, and the Virtual Caregiver Support Call. Currently, there are **967** subscribers.

- The caregiver column for the Golden Gazette included a message about Parkinson's Awareness Month, Living Better with Parkinson's Disease caregiver webinar, Yoga and Meditation for Stress Reduction caregiver workshop, Mindfulness in the Kitchen caregiver workshop, and INOVA Parkinson's and Movement Disorders Center- Virtual Fair.
- The monthly Caregiver Webletter was emailed this month to **910** people. The Webletter contained information on upcoming Caring for You Caring for Me, Elderlink's Virtual Support Call for Family Caregivers, caregiver stroke support group, caregiver webinar: Living Better with Parkinson's Disease, caregiver workshop: Yoga and Meditation for Stress Reduction, caregiver workshop: Mindfulness in the Kitchen, Chronic Disease Self-Management Program, Virtual Walk with Ease Program for Older Adults, and free family dinner at The Willston Multicultural Center.

- On Friday, April 1, 2022, caregiver staff and Insight Memory Care Center co-facilitated the virtual presentation, "Where to Turn for Help: Resources in Fairfax County." There were 10 participants.
- Caregiver staff attended the March Dementia Friendly Fairfax (DFF) task force meeting on Tuesday, April 26, 2022. Caregiver Staff and Diane Watson, Commissioner on Aging, conducted a requested Dementia Friend Information session on April 12, 2022, for the Parkinson Social Network, non-profit and had 13 participants.
- The Fenwick Foundation Partnership supports family caregivers by providing free outside events and activity opportunities, such as tickets to theaters, plays, musicals, baseball games, and more. Currently, The Fenwick Foundation is providing access to virtual and in-person events live shows, music events, museums, ballets, soccer games, magic shows, orchestras and more. The program accepts referrals from the Department of Family Services, adult day health centers, and other county programs. The program currently has **34** participants.
- Senior Express provided **21** round-trip rides to **11** unduplicated clients, and **47** hours of respite to their family caregivers for the month of March.
- The Covid Grocery & Medication Assisted Transportation program provided 7 round-trip rides to 5 unduplicated clients for the month of March.
- The Discretionary Funds, which provide durable medical equipment and adaptive equipment to clients who need financial help, aided **5** clients/caregivers, providing **9** items in March.
- The Residential Repair & Renovation Program (R&R) helps seniors 60 yrs. of age or older remain safely in their home by providing home repairs and modifications. In April, 4 new referrals were received, 5 jobs were completed, and 6 are in process. The program replaced front door locks,

painted doors, installed two stairlifts, fixed a furnace and sent a plumber to diagnose a leaking shower. Pending jobs include installation of grab bars, handrails and another stairlift, repairing a bathroom floor, replacing rotted wood, weather-stripping doors, painting exterior windows, replacing refrigerator gasket stripping, redoing a complete shower and caulking a tub/tile/floor.

- The Occupational Therapist (OT) Consultation Program sends out an OT to perform a home safety evaluation for A&A clients. Clients are referred to this service by their case worker. There were **10** new referrals received in April and **7** were completed.
- The Chore Service Program allows AAA to provide services for A&A clients, 60 yrs. or older, who can no longer perform these tasks themselves and who do not have the means to hire someone to provide the specified service(s). The first-ever Chore Services job was successfully completed to declutter, move items to storage & clean the client's home, preventing this client from losing his housing voucher and permanently becoming homeless. There are currently 4 jobs in process.

Ombudsman Volunteer Program was one of 11 winners out of 149 nominees. The Ombudsman Program is always grateful for its ombudsman volunteers and thrilled they have been acknowledged for their dedication and hard work in 2021.
- Ombudsman Volunteers were celebrated and recognized with an in-person gathering and luncheon. Ombudsman Program puts together a special event for its ombudsman volunteers each year to show its appreciation. Without them, the Ombudsman Program could not do what it does!
- Ombudsman Program's next virtual inservice training for ombudsman volunteers is scheduled for May. In-services are continuing education trainings for ombudsman volunteers and are held every other month. In-services focus on different topics and are opportunities for Ombudsman volunteers to share their experiences and ideas.
