- Dranesville District is the 'host' for the April 19 COA meeting. The agenda will include a presentation by COA Commissioner Irv Katz on From Intergenerational Programs to Intergenerational Community.

• At the May 23, 2023, Board of Supervisors' meeting, the BOS will adopt the SHAPE the Future of Aging Plan, proclaim May as Older Americans and Adult Abuse Prevention Month, and recognize students winners of the 50+ "Shark Tank" Technology Challenge.
