Highlights

- The Chair of the Fairfax Area Commission on Aging (COA) presented budget testimony during the April 17 Board of Supervisors budget hearings.
- The Northern Virginia Advocacy Network (NVAN) began the process of developing the legislative and budgetary priorities for the 2025 legislative platform with local AAAs and community leaders at the annual brainstorming session on April 16th. NVAN participants will vote for the 2025 NVAN legislative platform at the May 31st NVAN meeting.

Nutrition: Home Delivered Meals (HDM)

- The Nutrition Unit is currently in the process of filling the vacant Social Services Specialist III position. The position closed on Friday, April 19th.
- The Nutrition Unit continues to provide HDM services to eligible adults over age 60 or adults over age 18 with a disability.

Nutrition: Congregate Meals

- The Congregate Nutrition Program has been working with the DFS Clinical Coordinator and GMU's College of Public Health to host a total of 3 dietetic interns
 - in individual two-week community nutrition rotations through the Fairfax AAA. The first intern will start mid- May.
- The Congregate Nutrition Program continues to provide nutritious meals and opportunities for socialization and recreation to county residents aged 60 and over at Fairfax County Senior Centers and Adult Day Health Centers.

Caregiver and Support Services

- On Wednesday, April 10th, a *Dementia Friends Information Session* was held. **51** people registered, and **22** people attended the presentation.
- On Wednesday, April 17th, a caregiver webinar on *Navigating the Journey of Dementia* was held. **335** received the slide presentation and recording, and **204** people attended the live session.
- During April 2024, **10** Caregiver Alert Notifications were sent via email, text messages, and voice communication methods. The notifications contained information on ElderLink's Virtual Support Call, Dementia Friends Information Session, A Health & Wellness Vision Board Journey, Navigating the Journey of Dementia webinar, the 7th Annual Scam Jam, Chronic Pain Self-Management, Exploring the Dimensions of Aging, Fairfax County DFS Survey, Filling My Cup: Gratitude Journaling for Self-Care webinar. Currently, there are **1,494** subscribers.

- On April 24th, two staff attended The Northern Virginia Dementia Care Consortium's Subcommittee meeting to assist with planning and providing feedback and information for their annual Caregiver's conference.
- On April 27th, a staff member attended the Burke Farmers Market and provided a table with AAA resources. **26** people visited the table.
- On April 27th, a staff member provided an information table, at the AARP Life @50+ Academy "*Planning for Your Health, Wealth, and Happiness*" event at the First Baptist Church of Vienna, **50** people attended.
- The Dementia Friendly Fairfax (DFF) Action Team meeting met April 23rd and shared updates, targeted outreach, and possible new partnerships. The next meeting will take place on May 28th.
- On April 29th, two staff members attended and one hosted, The Virgina Caregiver Coalition, Professional Caregivers Subcommittee. The group shared updates, caregiver concerns, and the need for caregiver funding for respite.

- Discretionary Funds Programs, which provides durable medical equipment and adaptive equipment to clients who need financial help, assisted **3** clients, and provided **5** items through the Family Caregiver Discretionary Fund, and assisted **3** clients and provided **7** items through the Barbara Antley Gift Fund in April.
- The Residential Repair & Renovation (R&R) Program helps seniors 60 years of age or older remain safely in their homes by providing home repairs and modifications. In April, there were **3** new requests, and **o** jobs were completed.
- The Occupational Therapist (OT) Consultation Program sends an OT to perform a home safety evaluation for A&A clients. Case workers refer clients to this service. There were 4 new referrals, and 7 consultations completed in April.
- The Chore Services Program allows the AAA to provide services for Adult & Aging clients, 60 years or older, who can no longer perform these services themselves and who do not have the means to hire someone to provide the specified service(s). Services may include heavy housekeeping, yardwork, minor appliance repair and painting (limited). In April, 3 requests were received, and 3 jobs were completed.
