Executive Committee Meeting Discussion

- **Discussion -Visioning for SHAPE the Future of Aging** (Sharron, Irv)
 - Discussion – A. What is the vision; B. Accomplishing the vision
 - Mile Square, a neighborhood health concept established in Chicago in 1967 to provide quality healthcare to all residents in an underserved, urban community. Encompasses one square mile in Chicago.
 - Neighborhood Service Centers in Indiana, which formalize a network of health centers and senior programs to address areas of greatest need and with the fewest resources.

- Fairfax County itself is large, consider carving out areas by district to define livable areas, connecting all necessary services – senior housing, healthcare, transportation, schools, recreation, etc.
 - Determine a pilot program area where all IDC committees could be engaged and target a community for comprehensive treatment. Take advantage of what is already planned in Franconia. Connect with Supervisor Lusk and staff.
 - Irv Katz – American Planning Association (APA), Planning Advisory Report - Intergenerational Community Planning to be sent out after meeting for reference.
 - Chair Cathy Cole will send out draft Neighborhood Connections plan.
- **General Discussion –**
 - Remote and all Virtual meetings policy changes – COA will benefit when updated policy is voted on. Need to adopt the policy annually.
 - Whistleblower policy has been updated. Do not need to address at COA meeting at this time.
