#### District Host: Franconia, Supervisor Rodney Lusk - in-person

- Supervisor Lusk pleased to attend the COA meeting and started off with video presentation Affordable Housing in Fairfax County, <u>Oakwood Meadow Senior</u> <u>Residence in Alexandria</u>.
- Redevelopment of the Franconia Governmental Center to be completed by Summer 2025. The building will include the Franconia Police Station, the Franconia District Supervisor's office, the Kingstowne and the Franconia Museum. It will be the largest single county facility to date, other than the Government Center. Benefits will be intergenerational interactions and allow for building of trust with police.

- Seniors who supported our community over the years need the ability to stay in place near their family. Supervisor Lusk attributed his own success to his grandparents' support.
- COA "E" IDC Silver Shield Tax Mailing Initiative important to educate older adults about scams. BOS approved an informational flyer to be mailed in partnership with the Tax administration.
- Supervisor Lusk discussed various topics with COA commissioners home modification, home sharing, communication regarding access to services, transportation, pedestrian safety, anti-scam education, and veteran homelessness.
