1. **THREE** (3) copies of a facilities plan meeting the requirements of NFPA 1124 (2006) Edition, Chapter 7.
2. **ONE** (1) notarized and **TWO** (2) copies of a letter from the owner of the property granting permission for the sale of fireworks by the applicant on the property
3. **THREE** (3) copies of the Certificate of Insurance indicating a MINIMUM of a five million dollar (\$5,000,000.00) liability insurance which applies to the sale and storage of approved permissible fireworks
4. **THREE** (3) copies of the building commercial occupancy permit (Non-RUP or Zoning Permit)
5. **ONE** (1) copy of the approved Fire Safety & Evacuation Plan for mercantile occupancies requiring a plan.
6. A check or money order payable to "County of Fairfax" for the amount of **\$720**
7. The wholesale supplier's name and Fire Prevention Code Permit (FPCP) number

Fees for plan review and inspections are included in the Fire Prevention Code Permit (FPCP) Fee

**All conditions, surroundings, and arrangements shall be in accordance with the Fire Prevention Code.**
