

Implementing a Collective Impact Approach

All participants have a shared vision for change, including a common understanding of the problem and a joint approach to solving it through agreed upon actions.

Collecting data and measuring results consistently across all participants ensures that efforts remain aligned and participants hold each other accountable.

Centering Equity in Collective Impact

- 1. Ground the work in data and context, and target solutions
- 2. Focus on systems change, in addition to programs and services
- 3. Shift power within the collaborative
- 4. Listen to and act with community

Get to know what's driving the issue through Backmapping/ Root Cause Analysis Are we doing something and want to anticipate inequitable impacts?



> Apply the concept of Targeted Universalism


Universal Goal with Targeted Solutions

Structural Inequity produces consistently different outcomes for different communities. Opportunity Structures respond with necessary resources and multiple paths needed for different communities & individuals to thrive.





Backmapping / Root Cause Analysis

- The Proposal: What is the policy, program, practice or decision under consideration?
- **Desired Results:** What are the outcomes we want to achieve? What are the community-level conditions we aim to impact?
- Assumptions: What are our beliefs and ideas about the issue, situation, and people involved? How can we counter implicit bias?
- Analysis of Data: What data do we have? What data do we need? What does it tell us?
- **Community Engagement:** How have the people affected by the proposal been engaged? Are there opportunities to expand engagement?
- Strategies for Equity: Who will benefit from or be burdened by this action? What strategies will address vulnerability or build opportunity? How can we mitigate unintended consequences?
 - Implementation: Is the plan feasible? Is it adequately resourced? How can we think and act creatively to make "it" happen? What opportunities exist for partnership and alignment?
 - Contextual Factors: What factors might influence the proposal? What factors are in and/or out of our control? What factors can be addressed by partners or other stakeholders?
 - Accountability: How will impacts be documented and evaluated? Are anticipated outcomes being achieved? How can we course correct to achieve desired results?



Behavioral Health

Key Issue Area: Behavioral Health

- **Milestone Deliverable:** Children's Behavioral Health Blueprint (strategic plan for the children's behavioral health system of care)
- SCYPT Role: Endorse the blueprint (original 2016, new one coming this fall), champion initiatives and efforts, direct resources to support blueprint implementation, advocate for policies and funding to support blueprint implementation



Behavioral Health: Recent Accomplishments

- Expanded Short Term Behavioral Health Services to 15 Elementary Schools
- Trained clinicians in Family Intervention for Suicide Prevention
- Scheduled events for Children's Mental Health Acceptance Month
- CSB has received two grants from the Department of Behavioral Health and Developmental Services (DBHDS) to increase services to expand youth substance use treatment:
 - CSB trained staff in Evidence-Based youth SUD treatment (A-CRA) and added a clinician
 - CSB will accept youth substance use referrals directly from a local a local pediatric practice and added a half-time clinician through a grant from DBHDS
- CSB has deployed a clinician one day a week at Burke, Bryant and Montrose schools



Supporting Emotional Wellness in Youth and Families



Behavioral Health: Recent Accomplishments

- Implemented a universal screener for social and emotional learning in all FCPS schools
- Implemented Signs of Suicide program and conducted corresponding depression screening for all FCPS students in grades 7, 9, and 11



- FCPS/Fairfax agencies co-hosted Youth Substance Use Trends webinars
- Healthy Minds Fairfax supported the Behavioral Health Clinicians
 in the Community Schools



Behavioral Health: Current Planning Activities

- Continuing to hold activities to inform the Blueprint
- Exploring ways to Increase Services For Transitional Age Youth
- Exploring the possibility of Increasing the Number of Family Peer Support Partners
- May 6 NOVA CSB youth and family directors meeting with regional private providers and CSA managers to address gaps in youth SUD treatment
- Fairfax County Opioid Task Force to address increase in opioid overdoses





Behavioral Health: What's Next for SCYPT

- Current:
 - Support community input activities to inform the new Blueprint
 - Identify staff or partners to help us connect to community organizations and family groups
- This fall:
 - Provide feedback on goals and strategies
 - Provide recommendations to a draft of Blueprint

Key Issue Area: Career Readiness

- Milestone Deliverables: Implementation recommendations based on the recommendations of the Chairman's Task Force on Equity and Opportunity: Engage educators, business, government, and nonprofits, and involve youth and young adults to align their resources and initiatives to create an education-to-career system that better connects Fairfax's youth ages 16-24 who are not in school or working (opportunity youth) to in-demand careers.
- SCYPT Role: Endorse recommendations, champion initiatives and efforts, direct resources to support plan implementation, advocate for policies and funding to support plan implementation



Career Readiness: Current Planning Activities

- Convened task force steering committee
 - Developed common understanding of Opportunity Youth
 - Reviewed existing data and developed additional data needs
 - Compiled a partial list of existing regional efforts underway to support opportunity youth
 - Identified additional stakeholders to include on the team
 - Drafted four goals, a plan outline, and a tentative timeline







Career Readiness: Upcoming Planning Activities

 - Launch 2-3 year initiative
 - Establish quarterly goals and regular reporting process with SCYPT
 - Leverage county investment to secure amplifying investments from philanthropy
- 2024/2025
 - Continue to execute and evolve 2-3 year plan
 - Develop sustainability strategies
 - Report progress to SCYPT

- Milestone Deliverables: Community Schools framework, recommendations for expansion and sustainability
- SCYPT Role: Endorse framework (2021) and future recommendations, champion initiative, direct resources to support implementation and expansion, advocate for policies and funding to support implementation and expansion



Community Schools: Recent Accomplishments

- Special Projects Administrator hired by FCPS to lead CS efforts
- Whitman MS:
 - 76% of case-managed students improved or maintained English grades
 - 911 students and 692 families received support services
- Mount Vernon Woods ES:
 - Over 300 students and family members vaccinated through targeted outreach
 - Over 400 household members served by summer grocery card program
- Glasgow MS:
 - 100% of case-managed students had a decreased in behavioral referrals
 - 91% of case-managed English Learner students improved grades







Community Schools: Current Planning Activities

- Evaluation committee developing evaluation and reporting plan
- Multi-tiered evaluation of current sites in progress (May-August)
 - Parent and staff surveys
 - Structured interviews for key stakeholders
 - Impact data review
- Engage with School Board this fall for discussion and decisions on site selection and other implementation issues

- SCYPT Role: Endorse recommendations, champion initiatives and efforts, direct resources to support plan implementation, advocate for policies and funding to support plan implementation



MBK: Current Planning Activities

- Co-chairs for MBK Fairfax identified
- Identifying 5-7 key stakeholders for the MBK Fairfax Steering Committee
- Planning Engagement & Assessment Meetings
 - Evaluate impact & recommendations of One Fairfax, Strategic Plans, and Chairman's Task Force on Equity & Inclusion on boys and young men of color (BYMOC)
 - Assess current activities of Fairfax County government, FCPS, nonprofit, faith and business communities on behalf of, or affecting BYMOC
 - Discuss alignment of MBK Fairfax goals with these existing programs and strategies
- Exploring data on Fairfax BYMOC (prep work for the Action Plan)
- Spring/Summer:
 - Determine issue area(s) to focus on
 - Begin a policy review (prep work for the Action Plan)
- Future Planning:
 - Host at least one convening in the fall
 - Accept the MBK Challenge in the fall/early winter
 - Convene a Local Action Summit (Early 2023)
 - Create an Action Plan (within 180 days of Local Action Summit)

- Continue to champion initiatives and efforts in those plans and recommendations,
- Direct resources to support plan implementation, advocate for policies and funding to support plan implementation



School Readiness: Recent Accomplishments

- Fairfax County Office for Children leading Ready Region Capital Area, building Virginia's Unified Early Childhood System
- Fairfax County Public Schools has completed the Early Development Instrument (EDI) in all elementary schools with kindergarten.





School Readiness: Current Planning Activities

- Reconvened and expanded Equitable School Readiness Strategic Plan Implementation Planning Team in November
- Focusing on building equitable and sustainable family partnerships that support the priorities and desired outcomes families want for their children
- Developing a Family Partnership Framework, with eventual recommendations for a Family Partnership Hub
- County and FCPS Early Childhood Facilities team meeting to identify and explore the feasibility of including early childhood programming in CIP projects.





School Readiness: What's Next for SCYPT

- Review Early Development Instrument countywide results and plan for targeted investments.
- Endorse recommendations and ensure support and resources for Ready Region Capital Area implementation.
- Endorse recommendations and ensure support and resources for implementation of family partnership framework strategies.
