



Background Information HCAB Meeting, September 14, 2020

Public Hearing to Review Fair Oaks of Fairfax VA, LLC a.k.a Arden Courts of Fair Oaks Special Exception Application SEA 84-P -129-05. The Health Care Advisory Board originally reviewed Arden Court's application to increase its memory care capacity by 8 beds from 56 to 64 units on February 8, 2016. At that time, the HCAB determined the application was reasonable in terms of access, need, operations, and financial accessibility and recommended approval to the Board of Supervisors. Arden Courts did not move forward with the expansion and its special exception approval expired. The facility is located in Springfield District at 12469 Lee Jackson Memorial Highway, Fairfax, Virginia 22033

Health Insurance Coverage and Health Care Access in the Community as a Result of COVID-19 – Sarah Brinkmoeller from the Fairfax County Office of Strategy Management for Health and Human Services (OSM) will provide information regarding health insurance coverage and health care access in the community as a result of COVID-10 with an observation that many people have lost employment and therefore, may have lost insurance coverage. Included will be data from the Federally Qualified Health Centers (FQHCs) that serve Fairfax County.

Adult Day Care Center Proposed Amendments Background - At the July 28, 2020 meeting, the Board of Supervisors had planned to authorize the Planning Commission's and Board's public hearings on the proposed changes to the Zoning Ordinance provisions regarding Adult Day Care Centers These changes were presented to the HCAB at its May 11 meeting. The HCAB sent a memo to the Board of Supervisors expressing our concerns about these changes and our opposition to the proposal. At the last minute, this item was pulled from the Board's agenda, so the authorization did not take place. Subsequently, Chairman McKay and Sully Supervisor Smith requested a meeting with Marlene Blum and Phil Beauchene to discuss this issue. This meeting is currently scheduled for September 10.
