The residential treatment center at Oasis Behavioral Health is a joint commission level one program which provides services for dual-diagnosed adolescent males and females between the ages of 11 and 17 who are experiencing emotional, behavioral, and/or substance abuse difficulties. The foundation of our therapeutic approach to services at Oasis is based on the principles of cognitive-behavioral therapy.

We provide two tracks within our residential treatment program in Chandler, AZ. Our psychiatric track provides all patients in with the following services:

- Weekly individual therapy sessions
- Daily group therapy (Monday Friday)
- Family therapy
- Substance abuse education
- Academic services
- Daily living skills

The second track within our residential program is specifically designed for children and adolescents who are struggling with chemical dependency issues. The patients in this program

will receive all of the services that are provided in the psychiatric track, but they are also required to complete a series of 16 treatment lessons and must pass a written or oral chemical dependency exam. They must also participate in chemical dependency groups, work the 12-step program, and meet all set behavioral expectations by demonstrating the integration of treatment concepts.

In both of our programs, a single therapist is assigned to every patient upon admission. That therapist will develop an individual crisis management plan and then begin engaging the patient in individual therapy sessions. Within the first 7-10 days of treatment, the patient, their support system, and their child and family therapy team will attend a staffing, at which time the patient's presenting problems and multidisciplinary assessments will be reviewed in order for a master treatment plan to be developed.

Counseling sessions, therapy groups, and activity groups are led by therapists, nurses, and behavioral health technicians, all of whom concentrate on the *Living in Balance* curriculum. This curriculum guides patients as they develop and practice coping skills that can be used to reduce and/or alleviate their current symptoms. The *Living in Balance* curriculum also consists of therapy groups that are comprised of the following:

- Expressing anger
- Trust and addiction
- Irrational beliefs
- Stress and supportive relationships
- Relationships and feelings
- Dysfunctional roles
- Addiction groups

The families/guardians of the children and adolescents in our residential treatment program are consistently kept informed of the progress that the patient makes during the course of treatment.

In addition to therapy sessions, all patients participate in one or more of the following activities daily:

- Recreation activities
- Fitness activities
- Team building
- Vocational activities
- Psycho-educational groups
- Education programs
- Social skills groups

OTHER CONTRACTED PROVIDERS CONSIDERED:

All in-state CSA contracted Medicaid enrolled Residential providers were considered. However, most of them were either deemed to be inappropriate placements or denied admission due to the language barrier and level of acuity. DFS has referred this youth to over 20 different facilities and Oasis Behavioral Health is the only one that has accepted the youth and has a bed available.

PROGRAM DESCRIPTION:

The Stone and Gables Campus serve boys, 13 to 17 years old at the time of admission. The focus is to address a variety of complex emotional and behavioral difficulties that often accompany diagnosis of Autism Spectrum Disorders, Psychosis and behavioral challenges that result from diagnoses such as these. In general, the boys in the program have challenges in emotional development and in the ability to perform age appropriate developmental skills. Boys in this program may have had multiple struggles in school, family conflict, dependency or delinquent court involvement, absence of a healthy peer group, a challenge in vocational and life skills, and a history of unsuccessful placements.

The boys have typically had multiple psychiatric hospitalizations and repeated contacts with mental health, child welfare and possibly juvenile justice systems. These boys require intensive supports to help them maximize successes. The Stone and Gables Campus is designed to the meet the needs of these boys with staffing ratios that are 1:5 and with a Family Outreach Psychologist who is skilled in the navigation of complex family situations and in working with boys and stakeholders to develop kinship networks.

While a length of stay and discharge plan is individualized in each case, boys in the program typically require about 8 to 12 months of residential treatment.

From a behavioral perspective, the boys in the program have challenges in impulse control, emotional regulation and an inability to perform age-appropriate developmental skills. These skill challenges have often compromised their resilience and resulted in impulsivity, emotional dysregulation, and self-destructive behaviors.

OTHER CONTRACTED PROVIDERS CONSIDERED:

All in-state CSA contracted Medicaid enrolled Residential providers were considered after attempting community based and Private Day Schools. However, most of them were deemed to be inappropriate placements by the IEP team.

This is a for profit, group home sized residential facility with a capacity of 16 female adolescents between 12 and 17 years of age. They describe their program for teen girls struggling with Attachment and Trauma a "combined with a foundation of trust, love, and accountability, we employ a number of therapeutic methods designed specifically to treat attachment issues and trauma."

There is usually a 45-day period at the beginning of the placement during which there is no contact directly between the parents and the youth. The parents are always aware of how the child is doing because the program staff are in contact with them. The reason for this is to minimize the manipulation that happens often between the child and the parent. That time may be adjusted on a case by case basis and it is up to the therapists and treatment team in conjunction with the parents.

All of their therapists are trained in EMDR and TF-CBT.

Havenwood Academy School operates with a full academic staff of a licensed principal, licensed school counselor, two full-time lead teachers, and one 3/4 time math tutor. It is structured in that students are on a block schedule in which they take eight courses per semester. They use a three-semester calendar, including Fall, Spring and Summer semesters.

For more details, see attached program descriptions.
