**PRESENTING SITUATION & DIAGNOSIS:**

This youth entered foster care on December 19, 2018 and prior to entering the system, she lived with her mother in Annandale, Virginia. Since entering the foster care system, she has had 9 placements and 8 acute inpatient hospitalizations for stabilization. She was not able to maintain stability in her residential placement due to the frequent hospitalizations. Once she returns to her residential placement within a week or two, she has to be transferred back to the hospital for stabilization. She is a 15-year-old female who has a history of inpatient hospitalization stays, depression, anxiety, suicidal/homicidal attempts and recurrent mood swings. She is impulsive and has made several suicidal/homicidal attempts, such as taking pills, cutting, hanging herself and threatening others with a plan.

Her triggers are her peers, someone yelling at her or touching her, the word “No” and being redirection. Once she meets a peer she is very clingy and protective of that individual. So, if someone is being mean or rejecting that individual, she feels she has to protect that individual. She needs to be in a placement that will be consistent with the rules and expectations, hold her accountable for her actions, supportive, provide guidance and supervision. This client currently has three pending charges from her brief stay at Youth for Tomorrow (1/20-2/13/19). The next foster care court hearing is May 6, 2019. The Permanency Plan is for her to return to own home. The concurrent plan was relative placement but her aunt decided not be placement option due to her behaviors. The Department is searching for additional relatives and has also spoken to her mother regarding having a supportive network of friend/relatives that can assist her with her daughter. MEDICAID ENROLLMENT: Youth Villages is not a Virginia Medicaid participating provider.

LICENSE/ACCREDITATION: Youth Village is a licensed mental health residential treatment provider of Children and Youth by the Tennessee Department of Mental Health and Substance Abuse Services.

INSURANCE STATUS: Youth Villages is insured at appropriate levels per Fairfax County standards.

PROGRAM DESCRIPTION:

Youth Villages is an intensive residential program that specializes in boy with behavioral and emotional disorders. This advanced center is an expansive, hardware-secured residential environment designed to meet the needs of the treatment, educational and health needs of boys ages 9-17 with severe emotional and behavioral problems, but most of the boys at this time are 13-17. A child-to-staff ratio of 3:1 allows Youth Villages to provide intensive treatment while maintaining a level of safety that creates an environment of trust. Video cameras strategically placed throughout the building also support a setting where child safety is the utmost priority. Large, open spaces filled with natural light help alleviate the institutional quality often associated with programs featuring this level of intensity and security.

Youth Villages intensive residential facility is a locked facility and has four different courtyards. Each courtyard is able to house 14 boys where two boys will share one bedroom. The therapists are all master level and are trained in trauma-focused cognitive behavioral therapy (TF-CBT). All staff at the facility are also trained in collaborative problem solving. While at Youth Villages

the residents participate in daily group sessions and in at least weekly individual therapy. There are no phases or levels and safety is assessed daily to determine outings. Youth Villages client to staff ratio during the day is 3:1 and at night 8:1.

Youth Villages understands the importance of social connections and has a mentoring program concentrating on residents who do not have connections in the local area. The mentors are trained, have cleared background checks, and provide the boys with social interaction/outlets. Youth Village also provides recreational therapy twice a week with trained, certified therapists. Additionally, they have a group home program with on-site cottages for residents who move quickly through their program and are then able to step down and transition to a group home on the Youth Village property.

OTHER CONTRACTED PROVIDERS CONSIDERED:

All clinically appropriate providers currently under open contract were considered and none were available or appropriate based on the youth's diagnosis and situation.

The child has been denied by placements in Virginia, in addition to multiple out of state placements. The child has aggressive tendencies that have made it difficult and unsafe for him to be stepped down from a residential facility. Relevant local resources and existing CSA contracted providers have been explored and found to be unable to meet this child's/youth's current needs.

PROGRAM DESCRIPTION (from the provider's website):

New Hope Treatment Center offers specialized residential services for male and female adolescents ages 12 to 21. Through six distinct programs, they provide adolescents and their families treatment for a variety of challenges, including mood disorders, substance abuse issues, behavioral disorders, and inappropriate sexual behavior. Programs are designed to treat both normal functioning and intellectually and/or developmentally disabled populations.

This provider uses a trauma-informed, holistic, bio/psycho-social approach, working closely with Masters-level clinicians to coordinate a variety of services, ensuring a comprehensive approach to patient care. Multidisciplinary teams, including the patient, guardians, and all invested outside agencies, meet regularly to ensure collaboration and involvement by all invested parties throughout treatment.

The clinical staff uses a variety of best practice and evidence-based theories as core components to treatment including trauma-focused cognitive behavioral therapy, relapse prevention, dialectical behavior therapy (DBT), and motivational interviewing.

Evidence-based treatment approaches are also utilized for specialized populations, including self-regulation and DBT, kinesthetics, art therapy and a broad range of recreational therapies.

New Hope has clinical and administrative staff that completed an extensive training course in trauma-informed treatment of trafficked victims of sexual exploitation, allowing for individualized intervention and goals. New Hope looks at the dynamics that created risk for the client individually and risk factors of continuing in life while utilizing DBT. The curriculum was developed by Deepa Patel, Executive Director at Trauma and Hope. Deepa Patel is currently completing a mental health and trauma assessment with the youth and the youth's mother. The program's training with Deepa would allow for correlation in residential treatment and for services with Trauma and Hope upon the youth's return to the community.

OTHER CONTRACTED PROVIDERS CONSIDERED:

All in-state CSA contracted Medicaid enrolled Residential providers were considered. However, most of them were not appropriate to meet this youth's needs.
