# Chair Announcements, Lynne Garvey-Hodge:

- Denice Dressel introduced Daniel White as the ARB Administrator for the Heritage Resources Branch of DPD.
  - O Daniel White provided a brief overview of his background and introduced himself.

#### Land Acknowledgement, Kevin Bradley:

Kevin Bradley read the Fairfax County History Commission Land Acknowledgement.

#### **Opening Business**

• Louis Nuzzo, County Attorney, provided an update from the VFOIA OCA regarding the Gloss v. Wheeler guidance updates.

A motion was made by Lynne Garvey-Hodge regarding closed session:

"I move that the Fairfax County History Commission go into Closed Session, pursuant to Virginia Code Section 2.2-3711(A)(8) for the purpose of conducting consultation with legal counsel regarding specific legal matters requiring the provision of legal advice by such counsel. The subject matter to be discussed and considered is the application of the Virginia Supreme Court decision in the case Gloss v. Wheeler to the meeting procedures and activities of the History Commission."

The motion was seconded by Jordan Tannenbaum and other commissioners, and passed unanimously. The History Commission went into closed session at 8:02 PM.

#### A motion was made by Lynne Garvey-Hodge regarding closed session:

"In accordance with Virginia Code Section 2.2-3712, I move that the members certify that, to the best of each member's knowledge, only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act at Virginia Code section 2.2-3711(A)(8) and only such public business matters as were identified in the motion by which the closed meeting was convened were heard, discussed or considered in the closed session meeting of the Fairfax County History Commission."

The motion was seconded by Subhi Medhi and passed unanimously. Closed session ended at 8:57 PM.

#### **Minutes**

Approval of the June 7, 2023 Minutes

A motion was made by Esther McCullough regarding the History Commission Meeting Minutes:

The motion was seconded by Jordan Tannenbaum passed unanimously.

#### **Treasurer's Report**

- Sue Kovach Shuman reviewed the Treasurer's report for the period ending June 21, 2023. See Attachment 1 for the August report.
  - Sue reviewed the details of the report, specifically noted the county contribution since the last report period. Requesting motions to address over-budget issue on some items that were ordered.

#### **Staff Reports**

# Archaeology and Collections Branch (ACB), Aimee Wells:

- Aimee Wells, Fairfax County Park Authority, provided ACB program and project updates to the Commission. See Attachment 2 for the staff report.
  - O Discussion: Sue Kovach Shuman discussed previous correspondence on the issue and a new draft that she has circulated regarding the Pan Am Plan Amendment and Thompson Family Cemetery.

# A motion was made by Sue Kovach Shuman regarding the Thompson Family Cemetery:

"I move that the History Commission draft a letter by August 10, 2023, to the Planning Commission supporting the Archaeology and Collections Branch staff recommendation for the Thompson Family cemetery at Pan Am Shopping Center."

The motion was seconded by Tammy Mannarino and discussion regarding timing and recipient ensued. The motion was amended to include a deadline for the letter to the Planning Commission. The amendment was accepted and is reflected in the minutes above.

The amended motion was seconded by Tammy Mannarino and passed unanimously.

#### Heritage Conservation Branch, Sarah Petroff:

- Jenna Gilbert, Fairfax County Park Authority, gave project, program, and event updates regarding the Heritage Conservation Branch. See Attachment 3 for the staff report.
  - Discussion: Lynne Garvey-Hodge raised a question regarding the Mount Gilead public hearing for Carriage House demolition. Jenna indicated that no public hearing is scheduled yet but will confirm.

#### Virginia Room, Christopher Barbuschak:

• Christopher Barbuschak, Fairfax County Public Library gave program, collection, and staff updates regarding the Virginia Room. See Attachment 4 for the staff report.

#### Heritage Resources, Laura Kviklys:

• Laura Kviklys, Fairfax County Department of Planning and Development, gave projects, program, and staff updates. See Attachment 5 for the staff report.

#### **New Business**

# Van Dorn Metro Station citizen requested name change, Russell Brooks:

• A constituent residing in Springfield (Taylor Brigman, student at Spelman College) reached out regarding concern with the name of Van Dorn Metro Station, after

conducting research Taylor Brigman learned that station was named after a Confederate General. Commissioner Brooks met with Taylor Brigman who requested support from the History Commission in requesting a renaming of the station and has started a petition.

- Anne Stuntz: Noted that this was discovered during the previous Confederate name inventory, and there is a process in place for street name changing which could be used a reference.
- General discussion among commissioners regarding the Confederate Names
   Committee including the history of street name changes and costs associated (157
   Confederate-associated names are on the list).
- o Jordan Tannenbaum: Would like to invite Taylor Brigman to the next History Commission meeting to share the research and findings.
- o Russell Brooks: Recommended that History Commission provide a letter to WMATA regarding the requested name change.
- o Subhi Mehdi: Requested that a classification or guidelines for prioritization of how names to change rise to the top of the list.
- General discussion among commissioners regarding the approach and request to following City of Alexandria process for renaming of Confederate-named streets and places due to the location of the Metro Station and Van Dorn Street.
- O David Meyer: Provided an overview of the City of Fairfax's Confederate name changes. Northern Virginia Transportation Commission role in Metro and public transportation. Indicated that there may be financial challenges associated with changing WMATA Metro Station name. Recommends that the approach should be to work with the City of Alexandria prior to coordinating with WMATA since Metro Station names are based on surrounding neighborhood and street names.
- O Tammy Mannarino: Noted that many Confederate names were added in 1953 through a single ordinance.

#### A motion was made by Russell Brooks:

"I move that I [Russell Brooks] coordinate with the City of Alexandria to determine which next steps may be best appropriate for the potential renaming of Van Dorn Metro Station."

The motion was seconded by Tammy Mannarino and discussion regarding procedure and the process that the City of Alexandria will be following to rename streets named for Confederate officials followed. The motion was amended to rely on coordination with the City of Alexandria. The amendment was accepted and is reflected in the minutes above.

The amended motion was seconded by Elise Murray and Tammy Mannarino, and passed unanimously.

#### **Unfinished Business**

Joint Historic Facilities Advisory Committee, David Meyer:

- David Meyer stated that he, Elise Murray, and Aimee Wells met to discuss the need for understanding the inventory of historic sites and ensuring that it is comprehensive and there is a process to inform the History Commission prior to demolitions occurring.
- Elise Murray stated that the discussion was related to points of contact to stay in the loop on decisions such as the one to demolish the Mount Gilead Carriage House. A presentation would be needed for the ARB review of the demolition and is requesting that the same presentation be provided to the History Commission.
- Discussion of archaeological resources, Aimee Wells noted that the Mount Gilead Carriage House is built on slab.

# Section 106 Updates, Jordan Tannenbaum:

• Jordan Tannenbaum noted that a cell tower in Clifton is proposed and indicated that he would be happy to research this and write a letter for the commission's review.

# Fort Belvoir Advisory Committee (Ad Hoc), Tammy Mannarino:

- Lynne Garvey-Hodge and Tammy Mannarino gave an update on the Fort Belvoir Advisory Committee, see Attachment 6 for minutes, Attachment 7 for memorandum from Fort Belvoir, and Attachment 8 for the History Commission response. It was noted that while there are no current plans to rename Fort Belvoir, we are awaiting a response to our Letter to the Secretary of the Army. The next meeting is planned for either August 9 or August 22, 2023.
- Lynne Garvey-Hodge recounted a story about Isaac Woodard and President Truman regarding armed services integration.

#### Dunn Loring Letter & Updates, Thompson Cemetery Updates Sue Kovach Shuman:

• Sue Kovach Shuman noted that a meeting has not occurred with anyone from Dunn Loring but has drafted a letter to understand the rationale behind the Dunn Loring Administrative Center decision. Is requesting the History Commission feedback on the draft letter.

#### A motion was made by Tammy Mannarino:

"I move that Sue Kovach Shuman spearhead the letter regarding the Dunn Loring Administrative Center Decision and the History Commission to go out by by August 18, 2023."

The motion was seconded by Subhi Medhi and discussion regarding a deadline followed. The motion was amended to include a deadline for the letter release. The amendment was accepted and is reflected in the minutes above.

The amended motion was seconded by Subhi Medhi and passed unanimously.

# African-American History Inventory (AAHI) Database Project, Lynne Garvey-Hodge:

• Lynne Garvey-Hodge gave the updates that were provided by Advisory Member Mary Lipsey. Mary Lipsey received information from a resident of California that is planning a trip to Alexandria to explore family history.

• 50 items added to AAHI in July, if commissioners have items to add to email them to Mary Lipsey.

# <u>List of County History Groups Project, Kevin Bradley:</u>

- Kevin Bradely briefly noted that he is working to fill in blanks in information and has requested the History Commission assistance in reviewing the information. Kevin has requested that the commissioners email him directly to and will compile the updates into the final document.
- General discussion among the commissioners and clarification regarding qualifiers for "history group" followed.

# 2024 Budget Updates and Financial Operations, Cheryl Repetti and Elise Murray:

• Elise Murray indicated that the letter contained instructions regarding the upcoming Fiscal Year (FY 2025) and indicated that the History Commission should request a budget amount consistent with past amounts.

• Elise Murray indicated that work is continuing and there are no major updates.

# <u>History Conference and Awards Committees, Lynne Garvey-Hodge:</u>

- Lynne Garvey-Hodge noted that the minutes for the History Conference Committee have been revised to address name correction and provided updates regarding guest speakers and events. The next committee meeting will be August 28, 2023, at 7:30 PM in the Fairfax City Library, Room 214. For the History Conference draft agenda, bookmark, and meeting summary, see Attachment 9.
- Lynne Garvey-Hodge indicated that the following awards are being discussed and will be shared once recipients are selected.
  - (1) Mayo Stuntz Award, (2) 1-Edith Moore Sprouse Award, (3) 2-Life Time Achievement Awards & (4) 1-Distinguished Service Award

# Advocacy Committee, Anne Stuntz:

- The Advocacy Committee met in June and July, see Attachment 10 for draft June minutes and Attachment 11 for draft July minutes.
- Subhi Mehdi indicated that the \$700 budget for on supply purchases for outreach tables was exceeded by by \$26.95. Discussion among members regarding the proper accounts to charge for certain materials. Based on the discussion that ensued it was realized that the Advocacy Committee did not go over budget.

#### A motion was made by Elise Murray regarding History Conference expenses:

# A motion was made by Subhi Medhi that:

The motion was seconded by Tammy Mannarino, discussion regarding which items are being updated, ordered, printed and how this prioritization occurred followed. Esther McCullough opposed the motion. The motion passed with Esther McCullough dissenting.

# Ethnic and Oral History Committee, Esther McCullough:

- Esther McCullough indicated that the committee did not meet in July but will be meeting on at 5:00 PM on August 15, 2023, at the Freeman Center.
- Lynne Garvey-Hodge indicated that the video interviews will be available for viewing once they are placed on the History Commission website.

# A motion that Cheryl Repetti recommended regarding website updates was made by Esther McCullough:

"I move that a new section be added to the History Commission website for the video interviews once available."

The motion was seconded by Tammy Mannarino and passed unanimously.

# 250<sup>th</sup> Commission, Subhi Mehdi:

• Subhi Medhi indicated that the commission met on July 26, 2023, and provided an overview of the subcommittees of the 250<sup>th</sup> Commission. Two big themes that are emerging – the revolution wasn't just a war but a revolution of ideas; and Virginia's history is America's story – it's not a celebration but a commemoration of the independence because there is still a lot of work to be done.

- Lynne Garvey-Hodge indicated that August 3<sup>rd</sup> is Esther Day, and proceeded to tell the story of how this day came to be and the meaning of it.

- Anne Stuntz highlighted the Sully Historic Site will be in between managers for about a month which will have implications on the building operation hours, citing potential concerns regarding unofficial and unapproved exploratory exercises of the archaeologic sites by the public. The history community needs to support the Sully Historic Site but other than suggesting that people drive by periodically, does not have specific recommendations for how to do so at this time.
  - Lynne Garvey-Hodge told a story about the renovation of the Sully Historic Site by the late Michael Rierson.
  - o David Meyer indicated that he would be willing to contact Supervisor Smith of the Sully District to raise this concern and increase police presence at the site.
- Tammy Mannarino mentioned that there are Gum Springs Juneteenth buttons and other materials/handouts that could be of interest to the commission located at the back table for taking.
- Lynne Garvey-Hodge mentioned a presentation that she will be providing for Women's Equality Day.

June brought with it a Phase I (identification level) survey at the property historically known as the Fairfax Arms. Archaeologists dug 40 shovel tests, 80% of which were positive for historic period artifacts. The information gained from the Phase I will guide further Phase II testing to be started later this summer/early fall. For now, though, the lab is busy cleaning and cataloging the artifacts found during this first phase of work.

ACB staff, led by Kelsey Atwood, collections manager, attended history camps at a variety of park historic sites to teach kids about Fairfax County history and the work of archaeology and collections management.


Staff led by archaeologist Tyler Ball has completed the compilation of background research and scanning of information from the VA Room for 75% of the recorded cemeteries in the county. Additionally, 15 cemeteries have been surveyed comprised of nearly 1000 head and footstones and ~800 graves. This recordation includes plotting the graves and stones using highly accurate survey equipment, photo documentation, and where possible, transcription. Most of the remaining cemeteries to be surveyed will be boundary survey only at this phase of work. Most recently, Aimee Wells and Colleen Boyle have surveyed Cranford United Methodist Church and assisted the church with their ongoing ground penetrating radar survey.

Cemeteries have been central to the review process of two projects that recently went before the planning commission. The first, known as the Hunt Club cemetery or Lake Fairfax Drive cemetery has been delineated by Dovetail archaeology, however during the Planning Commission meeting, community members urged further and more extensive research prior to Planning Commission approval. The case has been deferred for vote until the September Planning Commission meeting.

Additionally, the Thompson Family Cemetery, surrounded by the Pan Am shopping center. While the Comprehensive Plan Amendment did go through, ACB has asked for further work to ensure that there are not graves outside the current bounds of the Thompson Family Cemetery prior to Zoning Approval, which has not yet been sought.

- Gum Springs Architectural Survey and Historic Context- From May-July 2023, DPD staff met with representatives of the Gum Springs Community to discuss potential consultants for their upcoming historic resources survey. A Notice To Proceed (NTP) with the project should be forthcoming in the next few weeks.

# **Current Development Cases:**

- Fairfax Hunt Club: (1321 Lake Fairfax Drive) Background: Applicant seeks rezoning of the parcel to increase density for multiple single family dwelling units. Fairfax Hunt Club and a non-associated cemetery are located on the site. The core of the extant clubhouse is a ca. 1790, two-story, three bay, log house that was moved to its current location from Vienna in ca. 1951. The Fairfax Hunt Club is not listed in the Inventory of Historic Sites; however, the property has specific language in the Comprehensive Plan and DPD staff is recommending preservation in place. Staff recommended that the house remain on the site and be moved to a parcel located adjacent to the cemetery to meet the minimum acreage as outline in the Comprehensive Plan. The Planning Commission held a hearing on July 26, 2023 and has deferred their vote until September 27, 2023.
- Judicial Center Complex, Comprehensive Plan Amendment- DPD Heritage Resources staff are in consultation with DPD and ZED staff regarding draft language for the Judicial Center Complex. The Plan Amendment is in draft form and scheduled for hearing before the Planning Commission on September 20, 2023.
- Goldsmith House (2754/2758 Chain Bridge Road)- Listed in the Fairfax County Inventory of Historic Sites in 2021, the 1918 single family dwelling is proffered to include preservation and maintenance in its current location. The application is scheduled for hearing before the Planning Commission on October 4, 2023.
- **DeBell/Sunnyside**, **Centreville**: DPD staff are waiting on resubmission from the applicant; however, a Phase II architectural report has been submitted to DPD and the Virginia Room.

#### **Other Items**

• We want to welcome Heritage Resources new Planner III, Daniel White! Daniel will be working with the ARB as their new administrator. He holds a Bachelor of Science in Environmental Design from Auburn University, and a Masters of Historic Preservation from the University of Georgia. DPD staff are thrilled to have him on the team and look forward to working with him.

- Cemetery MOA with the Fairfax County Cemetery Preservation Organization (FCCPA)- The Cemetery MOA between the History Commission and the FCCPA has been submitted and is going through the appropriate channels. Date of MOA execution: TBD.
- Meeting between DPD/FCPA/Executive Committee- A meeting is scheduled between DPD staff, Fairfax County Park Authority, and the Executive Committee to discuss a streamlined approach to the county's financial policies. The meeting is scheduled for August 29, 2023.
- Black/African American Historical Marker Project: DPD staff conducted site visits for final marker locations for the in partnership with Facilities Management Division and other county representatives for the Colin Powell and West Springfield markers. A site visit at the Government Center on August 3, 2023, is planned for the Lillian Blackwell marker. Two parks in in McLean are being evaluated for the placement of the Gunnell's Chapel marker.
- African American Outreach StoryMap: Stephanie has compiled a working list of historic African American communities and resources in Fairfax County. She will be (or has been) reaching out to HC members for assistance on consolidating, reconciling, and verifying the list. If you know of any community members who may be able to help with this project, please let Stephanie know. This is an active project and DPD staff are interested in collecting information on sites from the public.
- **Recording Meetings**: At the June History Commission meeting, the Commission asked for the status of meeting recordation for other BACS in the county: A & F Board only records fully virtual meetings, Wetlands Board records and posts all meetings.
- **Virtual Meetings Teams link:** Beginning August 3, 2023, the Teams link for all Commission and Committee meetings will be provided to the Chair (or Committee Chair) to be disseminated to Commissioners who require virtual attendance for meetings.

# 1. Call to Order and Verification & Audibility of Remote Participants

a. Chair Tammy Mannarino called the meeting to order at 7:35 with 7 members present in person. Lynne Garvey-Hodge joined the Teams connection soon after. Lynne stated that she was participating remotely because she was out of town. There was a motion duly seconded to verify that she could be adequately heard that that her remote participation comports with our Remote Participation Policy. The motion passed unanimously.

#### 2. Status of Fort Belvoir Streets Named for Confederate Generals

- a. The Committee discussed the Memo received from the Department of Public Works on 21 June 2023. The group formed consensus around the idea that while the names selected were not objectionable, there was a missed opportunity to recognize previous occupants of the land as well as previously unrecognized military personnel. Tom Shoop made a motion: I move that we, as a committee, write a letter for the signature of the History Commission Chair in response to the Memorandum signed by John Pilcicki and Mandy Kelley dated 21 June 2023. This letter should be completed by July 14, 2023. The motion was seconded by Subhi Mehdi and Jenee Lindner. It passed unanimously. In preparation for composing the letter, Jenee asked Tammy to provide the committee with previous input supplied to Fort Belvoir for consideration. Russell and Tammy will take the lead on creating a draft and seeking input and comments from the Committee.
- b. The Committee discussed participation in the Fort Belvoir Street Renaming Ceremony planned for July 26<sup>th</sup> at 10am at Woodlawn Chapel. Both Cheryl and Tammy received invitations to the ceremony through their previous participation with the Fort Belvoir Stakeholders meeting in September 2021. Tammy has been asked to serve as a speaker at the event. She has not agreed to do so, but has made it clear that if she does, she would not be representing the History Commission with her remarks but rather speaking only on her own behalf. Some discussion of the pros and cons of that opportunity ensued. As more than two Commission members are interested in attending the ceremony, Tammy will ask that DPD put the event on the calendar and ensure that announcements are made to ensure compliance with VFOIA. Lynne asked Tammy to forward the invitation to the entire Committee.

# 3. Providing Accurate Historical Information regarding Fort Belvoir's 1935 Name Change

- a. Tammy shared a strawman outline with the in-person Committee members. She apologized that it was created at the last minute and proceeded to read it aloud so that it could be discussed with remote and in person attendees. Committee members agreed that the scope should make clear that the History Commission will not be taking a position on the name change but providing information on how and why the 1935 name change occurred.
  - b. After the previously mentioned letter has been executed, the Committee will turn its attention to writing/editing the paper.

#### 4. Next Meeting(s)

- a. Jordan Tannenbaum suggested that the Committee might be interested in touring the Army Museum Storage Facility in the future. The entire committee was enthusiastic about this possibility.
- b. The Committee decided to hold off on scheduling their next meeting until after the letter and some initial work on the paper has been completed.

#### 5. The Meeting adjourned at 9:38pm.

#### MEMORANDUM FOR RECORD

SUBJECT: USAG-Fort Belvoir Garrison Operations Order (OPORD) 23-019: Fort Belvoir Street Renaming

- This memorandum is to provide notification to the Fairfax County Dept of Planning and Development concerning the issuance and execution of the USAG-Fort Belvoir Garrison Operations Order (OPORD) 23-019: Fort Belvoir Street Renaming, to be completed no later than 26 July 2023.
- 2. The USAG-Fort Belvoir Garrison Operations Order (OPORD) 23-019: Fort Belvoir Street Renaming is Fort Belvoir's execution of a directive from the Secretary of Defense (SECDEF) to implement the Naming Commission's recommendations by replacing all street signs on Fort Belvoir that memorialize willing participants from the Confederacy.<sup>1</sup>
- The Naming Commission identified four (4) streets names on Fort Belvoir that were determined to be Confederate-affiliated assets.
- a. Lee Road was named after Confederate General Robert E. Lee, who led the Army of Northern Virginia from 1962 until its surrender in 1865. Lee was appointed the General in Chief of the Armies of the Confederate States in February of 1865 and surrendered to General Ulysses Grant on 9 April 1865, at Appomattox Court House.
- b. Beauregard Road was named after Confederate General Pierre Gustave Toutant (P.G.T.) Beauregard, who ordered the first shots of the American Civil War from Fort Johnson and initiated the Battle of Fort Sumter on April 12, 1861. Beauregard, along with William Porcher Miles and Gen. Joseph E. Johnston, designed and produced the Confederate Battle Flag.
- c. Stuart Street was named after Confederate General James Ewell Brown "Jeb" Stuart, who led many regiments in key battles of the Civil War and was ultimately given command of the calvary brigade for the Army of Northern Virginia, under General Robert E. Lee.
- d. Johnston Street was named after Confederate General Joseph E. Johnston, who was one of the first, highest-ranking U.S. Army Officers to resign and enter the Confederate States Army after Virginia seceded from the United States in 1861.

 Since the Naming Commission did not select names, the installation chose names after discussions with the Fairfax County History Commission, as well as efforts to contact the Gum Springs Historical Society and the League of Descendants of the Mount Vernon Enslaved. The selected names were chosen to support current Army values and celebrate the 75th anniversary of the establishment of Executive Order (EO) 9981.

- a. EO 9981 Road refers to Executive Order 9981, that banned segregation of the Armed Forces and was signed by President Harry S. Truman on July 26, 1948. The name will replace Lee Road, which is near a historical African American cemetery, and is the site of a former segregated housing area on Fort Belvoir. The street will be renamed on the 75th anniversary of the signing of EO 9981.
- Essayons Road refers to the official motto and song of the Army Corps of Engineers. From its beginning in 1910 up until 1988, Fort Belvoir operated as a post for the Army Corps of Engineers. "Essayons" is French for "Let us Try."
- c. Sapper Street recognizes "sappers", the elite combat engineers who support front-line infantry. In recognition of Fort Belvoir's long history as an engineer post, most of the street on Fort Belvoir are named after engineers, and twenty-seven (27) streets are named after former Chiefs of Engineers.
- d. Castle Road refers to the castle insignia of the US Army Corps of Engineers and is related to many historic and present elements on Fort Belvoir. In particular, the street currently runs adjacent to Castle Park, and historically, Fort Belvoir's newspaper during its time as an engineer post was called "The Castle."
- 5. Your review of this memorandum and response would be appreciated within 30-days of receipt. No response by Fairfax County within the allotted timeframe will be taken as approval of the documentation.

Thank you for your memorandum of 21 June 2023, Subject: USAG-Fort Belvoir Garrison Operations Order (OPORD) 23-0109: Fort Belvoir Street Renaming (received 1 July 2023). Members of the Fairfax County History Commission, in support of the county's Board of Supervisors, appreciate the opportunity to provide feedback on the memo and the documentation it includes. The history of Fort Belvoir, including the land and the people who have lived there, is important to our community and to our country. In this letter we seek to improve the accuracy of documentation related to the renaming of streets on the post and advocate for moving forward with a more inclusive presentation of local and national history.

We respect the new names announced to replace those of Confederate generals. They recognize the Army Corps of Engineers and highlight President Truman's landmark executive order. We also appreciate the location of the street proposed as E.O. 9981 Rd., as the former site of segregated housing. However, we believe the new names represent a missed opportunity to recognize Indigenous and African American individuals and groups who have made significant contributions to history prior to and during the existence of the military installation. These include Native American groups who occupied the peninsula before colonization, men and women who were held in bondage at the Belvoir Plantation, individuals and families who built and lived in the Free Black Community of Woodlawn, and African American soldiers who served at Fort Belvoir. As with many existing street names on post, association with Fort Belvoir might not be required. For example, streets in the segregated Youngs Village section of the fort were once named for African American war heroes. These along with the village's namesake, Charles Young, would have been laudable candidates for acknowledgement by having their names restored to the post. We are at the threshold of a decisive moment in time, at which we must do all we can to honor and accurately respect our collective past.

We understand that deciding to name installations, roads, and/or structures after individual people can require additional research and approval. Nevertheless, it is being done with great success elsewhere in this great land. Note the recent renaming of Fort Benning to Fort Moore, honoring Lt. Gen. Hal Moore and Julia Compton Moore. We had an opportunity in our work as a Commission on the Fairfax County Confederate Names Inventory project to examine place names on Fort Belvoir. As your memo notes, no fewer than 27 streets at Fort Belvoir are named for former Chiefs of Engineers and most of the names honor individual engineers as

well. There are other street, building and village names honoring historic homes (Cedar Grove, Gunston, Woodlawn, Vernondale) and area landowners (Mason, Gillingham, Fairfax, Troth, Mero). Continuing the use of these names and not permitting the consideration or use of additional ones, freezes in place a historical error: the failure to recognize and honor the achievements of African Americans affiliated with Fort Belvoir history. Further, there also remains an opportunity to honor the Native Americans who once called this vast swath of land home. For instance, when the Washington Commanders put aside the team's former name but needed time to select a new name, they used a placeholder name, Washington Football Team. The Army could consider using this strategy for the roads other than EO 9981 Road to buy time to conduct a thorough investigation of the history we are describing.

As to the documentation referenced earlier, we note the Memorandum in receipt contains several factual errors and omissions. First, it says Executive Order 9981 banned segregation in the Armed Forces. The text of the order, however, mandates not desegregation specifically, but "equality of treatment and opportunity" for all military service members. That distinction is important in the context of Fort Belvoir because Army leadership did not believe segregation constituted unequal treatment. Many posts, including Fort Belvoir, remained segregated for several years after President Truman's order. Second, the memo contains a typo, that Robert E. Lee assumed command of the Army of Northern Virginia in 1962. Obviously, the correct year is 1862. In addition, the descriptions in paragraph 3 of individuals other than Lee for whom streets were named take the form of accolades, without mentioning that these officers took up arms against this country's Constitutional democracy in order to defend the concept and practice of enslaving individuals. Such is a contravention of the human rights United States citizens profess to affirm and militarily protect.

We strongly urge the Army to more broadly expand the official naming of streets, buildings, and other identified areas (such as parks or recreation facilities) that reflect a more inclusive view of Ft. Belvior's history, the current diversity of the base and that which would help to build a more equitable future from a historical perspective. As a long-time supportive neighbor and friend of history, we also request that the leadership of Fort Belvoir open a dialogue with us to examine ways, beyond naming, to educate the public about African Americans and Native Americans who were associated with the installation and the land upon which it is located. We look forward to building a more collaborative and productive relationship with Fort Belvoir. We look forward to your response.
