The Fairfax County History Commission conducted a wholly electronic meeting on January 4, 2023.

**Call to Order**

**1. Audibility of Members' Voices**

The Chair called the January 4, 2023 meeting to order at 7:30 p.m. Before proceeding, she read the following script:

*To conduct this meeting wholly electronically, the History Commission needs to make certain findings for the record to evidence our compliance with all applicable laws. These motions address this compliance.*

*First, I am going to conduct a roll call and ask each board member participating in this meeting to state your name and your location. I ask that each of you pay close attention to ensure that you can hear each of your colleagues.*

At this point, the Chair passed the virtual gavel over to David Meyer that she might be heard to make the following motions:

*I move that the History Commission certify for the record that each member's voice may be adequately heard by each other member of this Board.*

The motion was seconded by Esther McCollough and passed unanimously.

**2. Need for an Electronic Meeting:**

*Second, I move that the History Commission certify that the State of Emergency caused by the COVID-19 pandemic makes it unsafe for this Commission and the public to physically attend this meeting in person, and the usual procedures cannot be implemented safely or practically. As a result, I further move that the Fairfax County History Commission conduct this meeting electronically through a dedicated video- and audio-conferencing line, and that the public may access this meeting by calling 1-571-429-5982 and entering access code 993 767 333#.*

The motion was seconded by Esther McCollough and passed unanimously.

**3. Need to Dispense with FOIA's Usual Procedures to Assure Continuity in Government/Continue Operations:**

*Finally, I move that the History Commission certify that the matters on its agenda today relate to the COVID-19 emergency itself, are necessary for continuity in Fairfax County government, and/or are statutorily required or necessary to continue operations and the discharge of the History Commission's lawful purposes, duties, and responsibilities.*

The motion was seconded by Esther McCullough and passed unanimously. The gavel was passed back to the Chair.

## **Welcome and Announcements**

### Greetings and Overview of 2023, David Meyer:

- David Meyer, former Mayor of the City of Fairfax, gave a warm welcome to the Commission and particularly to the new Commissioners. David explained his decision not to seek reelection after 15 years of serving as an elected official in the City of Fairfax and discussed the achievements of the final six months of his mayorship. David discussed those accomplishments to illustrate the possibilities for the Commission to accomplish bold and impressive historic preservation goals in the years to come. David also encouraged the Commission to consider seeking federal funding for projects in the months to come. David concluded his remarks by thanking all the Commissioners, and specifically Cheryl Repetti, for their past leadership.

### Welcoming of New Commissioners and Chair Announcements, Lynne Garvey-Hodge:

- Lynne Garvey-Hodge welcomed the two new Commissioners, Tom Shoop and Kevin Bradley, and gave them the floor for brief introductions.
  - Tom Shoop gave a warm welcome to the Commission. Tom has been a Fairfax County resident for over 30 years. He is an editor and career journalist for the new publication *Government Executive*. Tom first became involved in the County's history following a story he published about the Oak Hill property and is currently working on a project focusing on the history of the Ilda Community.
    - Jordan Tannenbaum is paired with Tom as a senior Commissioner.
  - Kevin Bradley also gave a warm welcome to the Commission. Kevin is a lead archaeologist for the company New South Associates. Kevin is originally from northern Virginia and lived in a number of other cities throughout the south before moving back to Fairfax County five years ago.
    - Sallie Lyons is paired with Kevin as a senior Commissioner.
- Lynne noted the recent charge for the Commission to develop a resource clearinghouse for history organizations across the County. Lynne asked Commissioners to inventory all the history organizations in their districts.
  - Lynne asked Gretchen Bulova about a list of history organizations that previously developed. Gretchen noted that the list does exist, but it is not up-to-date. However, there is a committee on the 250<sup>th</sup> Commission that is currently developing a similar list that could serve as a starting point for the History Commission's inventory.
- Lynne recognized Jordan Tannenbaum as the Commission's Section 106 expert and gave the floor to him for an introduction.
  - Jordan discussed his appointment to and service on the Advisory Council for Historic Preservation (ACHP). Notably, Jordan's appointment to the ACHP was renewed by President Biden in 2021 and became Vice Chairman shortly thereafter. Over the past year and a half, Jordan has served as the acting Chairman until the Senate's confirmation of Chairman Sara C. Bronin last week.

## Minutes

### Approval of the December 7, 2022 Minutes

**A motion was made by Esther McCullough to approve the December 7, 2022 History Commission Meeting Minutes:**

*I move that the History Commission accept the minutes and pay the Clerk [Elliot Meyer].*

**Tammy Mannarino seconded the motion and the motion passed unanimously.**

### **Treasurer's Report**

- Sue Kovach Shuman reviewed the Treasurer's report for the period ending December 16, 2022. See [Attachment 1](#) for the December report.
  - Sue noted that the History Conference was \$1,277 under the \$5,000 budget and that the added conference expenses were paid.

### **Staff Reports**

#### Archaeology and Collections Branch (ACB), Aimee Wells:

- Aimee Wells, Fairfax County Park Authority, provided ACB project and activity updates. See [Attachment 2](#) for the staff report.
  - Tom Shoop thanked Aimee for her help with a recent research question.

#### Virginia Room, Christopher Barbuschak:

- Christopher Barbuschak, Fairfax County Public Library gave program, collection, and staff updates regarding the Virginia Room. See [Attachment 3](#) for the staff report.
  - Additionally, Chris highlighted that the bi-weekly book club reading of *Fairfax County, Virginia: A History* will officially commence on January 24. The initial meeting will discuss the timeline and organization of the book club.

#### Heritage Resources, Laura Kviklys:

- Laura Kviklys, Fairfax County Department of Planning and Development, gave survey projects, program, and staff updates. See [Attachment 4](#) for the staff report.
  - As a matter of business, Laura noted that the Commission must renew their National Trust for Historic Preservation membership for \$250.

**Jordan Tannenbaum made the following motion:**

*I move that the Fairfax County History Commission renew our National Trust for Historic Preservation membership at the cost of \$250.*

**Jenee Lindner seconded the motion. The motion passed unanimously.**

- In discussion of Laura's staff report, Tammy Mannarino commended Laura for her detail in the report. Tammy highlighted the Bus Rapid Transit (BRT) project and underscored the importance of incorporating the historical narratives into the project, particularly for the Mount Vernon District.
  - Following Stephanie Langton's staff report (see below), David gave more detail regarding the significance of the BRT project across the region.

Heritage Conservation Branch, Stephanie Langton:

- Stephanie Langton, Fairfax County Park Authority, gave program and event updates regarding the Heritage Conservation Branch. See [Attachment 5](#) for the staff report.

**Unfinished Business**

- Cheryl Repetti updated the Commission that a letter of acceptance for the Commission to be a consulting party in the I-495 Southside Express Lanes (SEL) Section 106 Process was submitted and accepted. The Commission is now officially a consulting party in the project.
- On a related note, Cheryl mentioned that the follow up letter regarding the list of consulting parties for the Coastal Storm Risk Management Feasibility Study Draft Agreement has not yet been sent.
  - Aimee Wells confirmed that the Archaeology and Collections Branch was added to the list of consulting parties.

Dunn Loring School Demolition, Sue Kovach Shuman and Tammy Mannarino:

- Sue Kovach Shuman spoke with one of the project leaders in December and had a verbal agreement to set up a meeting with the History Commission to discuss the potential demolition of the Dunn Loring School.
- Tammy Mannarino added that she reached out to the Mount Vernon School Board member Karen Corbett Sanders and cc'ed Supervisor Storck. Tammy was referred to another School Board member and is waiting to hear back from them.
- Jeff Clark, Fairfax County historian of FCPS schools and facilities, opened his comments by stating that he is not speaking on behalf of Fairfax County Public Schools. However, he explained that one of his duties as a part of the FCPS's Communications Office is to explain projects that are a part of the Capital Improvement Program to the public. Jeff stated that the current stage of the project is community meetings and gathering public comments regarding the design of the building. The project is still in the planning phase.
  - Tammy Mannarino asked Jeff if either of the two proposals that are seeking public comments involve adaptive reuse or are they demolitions. Jeff confirmed that the two proposals he is aware of are demolitions due to the age of the building and the existing design, which is considered unsuitable for a modern elementary school.

- Lynne Garvey-Hodge urged the Commission to read the extensive article on the FCPS website that documents the history of the building and includes a video at the end. The link to the article can be found [here](#).
- Lynne also encouraged the Commissioners to write to their respective School Board members to raise awareness about the historical significance of this project.
  - Anne Stuntz suggested that the Commission consider writing a formal letter to Fairfax County Public Schools urging the project to reconsider the designs for adaptive reuse.
- Jordan Tannenbaum asked Jeff if he is aware of any federal involvement on this project that might trigger the Section 106 process, particularly if there is any funding from the Department of Education or use of community block grants.
  - Jeff did not know and recommended that question be directed to FCPS's facilities office.
- Jordan also suggested looking into whether the property would qualify for the National Register of Historic Places or Preservation Virginia's list of most endangered sites.
- David Meyer noted the historic architectural styles of FCPS elementary schools and acknowledged that the current footprint is probably not conducive for current standards. However, David urged adaptive reuse could be possible at the direction of a gifted architect.
- Elise Murray attended one of the public meetings and emphasized David's point that the project leaders do not believe the current footprint is conducive to modern needs or traffic patterns (school bus and car drop-off access). Elise urged the Commission to talk with the School Board about this matter and not the Board of Supervisors, who do not have authority in this process.
  - David added that the School Board is the legal owner of the facilities and property in the Commonwealth of Virginia. The Board of Supervisors would only be involved if there was a bond or financing associated with the project.
- Additionally, David noted that two of the primary focal points for modern school construction are setbacks and security measures.
- Tom Shoop underscored his interpretation of the renderings involve a complete demolition.
- Sue Kovach Shuman emphasized that one of the primary concerns is the significant traffic along the adjacent roads, due to the development in the area. Even if the building is demolished, Sue suggested that other interpretive measures, like a marker or center, can still take place.
- Anne Stuntz agreed with Lynne to include this issue on the Advocacy Committee's agenda.
- Tammy Mannarino broadened the questions of consideration to whether this is the best site for this elementary school to begin with.
- Cheryl Repetti reminded the Commission to ask for adaptive reuse before considering compromises.

## **Committee Reports**

Budget and Inventory, Elise Murray:

- Elise Murray explained that recent health issues have delayed her submission of the budget request, but that she expects to submit the request to Cheryl and Lynne this upcoming month.
- Regarding the Inventory Committee, Elise will be contacting the committee members in the near future to schedule a meeting.

History Conference and Awards Committees, Lynne Garvey-Hodge:

- Lynne Garvey-Hodge noted that the History Conference Committee's next meeting will be January 25 at 7:30 PM via Microsoft Teams. The Committee will review the financial analysis of past conferences to revise the fiscal management for 2023.

African American History Inventory Committee, Lynne Garvey-Hodge:

- Lynne Garvey-Hodge touched on the future work of the AAHI and Mary Lipsey's involvement as an Advisory Member.

250<sup>th</sup> Commemoration, Gretchen Bulova:

- Gretchen Bulova explained that the Fairfax County working group's committees are beginning to take shape and meet. The statewide commission has switched to quarterly meetings.

Advocacy Committee and Annual Report, Anne Stuntz:

- Anne Stuntz noted that the Advocacy Committee will be meeting sometime this month and encouraged Kevin and Tom to consider joining.
- The work for the Annual Report will begin and Anne reminded committee chairs that she and Subhi will be soliciting committee summaries in the coming months.

Markers Committee, Cheryl Repetti:

- Cheryl Repetti announced that she volunteered to be the new chair of the Markers Committee. The Merrifield marker is currently under review and Cheryl will be updating the Commission in the coming weeks about its progress.
  - Lynne asked Cheryl who are the current members of the Committee. Cheryl replied that they are Cheryl Repetti, Anne Barnes, Carole Herrick, Esther McCollough, Elise Murray, and Tammy Mannarino. Additionally, Mary Lipsey, Barbara Peters, and Phyllis Walker Ford are advisory members.
- Tammy Mannarino requested Laura Kviklys to send out a revised list of the Commission's committees and members, including the involvement of the four advisory members.

Cemetery Preservation Committee, Lynne Garvey-Hodge:

- Lynne Garvey-Hodge noted there will be further updates in February regarding the Committee.

Ethnic and Oral History Committee, Esther McCullough:

- Esther McCullough is excited to continue the Ethnic and Oral History project and explained the project for the new commissioners. The next committee meeting will be January 17, at 2:00pm on Microsoft Teams.
  - Lynne Garvey-Hodge commended the Ethnic and Oral History Committee for their work over the past two years in their recording of oral histories across the County.

Resident Curator Program, Bob Beach:

- Bob Beach did not have anything further to add to the Resident Curator Program staff updates.

Bylaws Committee, Anne Barnes:

- Anne Barnes announced that the Bylaws Committee is planning to meet on March 7, 2023. Anne emphasized the request to see who are the current committee members.
  - Lynne asked the Commissioners to review the list of committees on the History Commission website and send Laura the list of committees that they are (or would like to) serve on.
  - Lynne Garvey-Hodge noted that the Commission received feedback from the County Attorney's Office regarding the proposed changes to the bylaws. Cheryl Repetti clarified that the County Attorney's Office recommended that the History Commission make a formal amendment to the bylaws so that the Commission can continue with the awards process.

Architecture Review Board, Elise Murray:

- Elise Murray shared her report on the sharefile ahead of the meeting. See [Attachment 6](#) for the report.
  - Specifically, Elise highlighted that a childcare facility was approved as a business in the historic Laurel Hill Adaptive Reuse Area.

Fairfax City, David Meyer:

- David Meyer noted that the City Council finalized the name changes related to the Civil War at the end of October. This completed the City's work to revise its narratives about the Confederacy and its commemoration of the Civil War.
- David also updated the Commission about the restoration of Old Town Hall.

Website Coordination, Cheryl Repetti:



- Cheryl Repetti updated the About Us page on the website to include the new and retired commissioners.

### **Announcements and Additional Comments**

- Carole Herrick announced that the McLean Historical Society will be celebrating their 30<sup>th</sup> Anniversary on January 10.
- Tammy Mannarino gave a tour of River Farm to the Thompson family of Thompson Dairy. Tammy and Chris Barbuschak announced that the book *Desegregation in Fairfax County Public Libraries*, co-authored by Chris, will be released on January 9. There will be a book release party on January 14 at the Fairfax City Public Library.
- Sallie Lyons announced that the Friends of Fairfax County Archaeology is having their annual meeting January 7.
- David Meyer appreciated the feedback from all the commissioners for their suggestions of the management of monthly meetings going forward.
- Jenee Lindner updated the Commission that the book about the history of the Jermantown Cemetery descendants is in the process of being published.
- Jordan Tannenbaum commended Lynne and David on leading their first meeting.
- In reference to the discussion about the Dunn Loring School, Bob Beach added that there could be a possibility for adaptive reuse for at least a segment of the building.
- Lynne Garvey-Hodge reminded the Commission that the Board of Supervisor's annual celebration of county volunteers is on January 20, from 6:00-7:30 pm at the Fairfax County Government Center.

**History Commission December Update**  
**Archaeology and Collections Branch**  
January 2023

December was relatively quiet for the Archaeology and Collections Branch. This allowed staff to catch up on a lot of the administrative work that is the less-than-exciting portion of our work.

Staff began their review of the combined Countywide Trails Plan and Bicycle Master Plan, dubbed “Active Fairfax”

This is a long-range plan intended to address the variety of trails and trail-networks in the county. This first-pass review cycle consisted of a GIS map analysis of trails that, as currently proposed could impact known historic resources. A more fine-level analysis will be done as the process moves forward through the various phases of public comment and input from various partner agencies.

This Saturday, January 7<sup>th</sup> at 9:30 a.m. at the James Lee Center is the Friends of Fairfax Archaeology and Cultural Resources (FOFA) Annual meeting. Dr. Elizabeth Crowell will be speaking.

**Fairfax County Public Library's Virginia Room**  
**Staff Report to the Fairfax County History Commission**

**January 2023**

- The *Herndon News-Observer* (1925-1946) and the single surviving issue of the *Fairfax Gazette* (1843) have been digitized and are now freely available on Virginia Chronicle. No updates regarding the *Fairfax County Sun Echo* newspaper. It is in the digitization queue at the Library of Virginia. LVA is very interested in more newspaper title representation from Northern Virginia and this particular paper is a priority for them.
- The Fairfax County Board of Supervisors minutes from 1924-1989 have also been digitized and are freely searchable and downloadable on the BOS website: <https://fairfaxcounty.civicweb.net/filepro/documents/8704/> The Virginia Room is also working with the Providence Chapter of the Daughters of the American Revolution who are currently hard at work transcribing the handwritten BOS minutes from 1870-1923.
- Received four oral history recordings and transcripts from Lake Braddock High School teacher McKenna Crews. She documented teachers' experiences while teaching before, during, and after the COVID-19 pandemic.
- The Virginia Room will have one high school student from the West Springfield Applied History class interning with us during the winter semester.

**Survey Efforts**

DPD staff continue survey efforts countywide:

- **Modern Architectural Survey, County Wide-** DPD staff has revised the scope to include approximately 150 mid-century building, sites, and districts of local and national significance. DHR has resubmitted the scope to potential consultants and work is slated to begin late winter 2023.
- **African American Context Study and Architectural Survey, County Wide-** No update from December
- **Gum Springs Study, Mount Vernon District-** No update from December
- **Centerville Architectural Survey-** Kick off meeting for the Centerville Study was held January 4; documentation efforts will begin in mid-January.

**Other Items**

- **Staff Positions-** Interviews for the Planner II position will begin January 9 and run through January 13.
- **African American Markers Program:** Four of the six markers are in their second round of comments, and one additional is in its first draft phase; the remaining marker is in the research phase. DPD staff plans to submit the next round of edits for comment to the AAMP Chair in January with a draft submitted to the full committee in February. DPD staff is working on finalizing an exhibit for the Government Center display case to be installed in late-January. A co-sponsored event will occur **February 7, 2023** (time TBD) celebrating all submission finalists.
- **Bus Rapid Transit Narratives (BRT):** DPD staff will develop and draft historic context narratives of approximately 350-500 words for seven BRT locations along the Route 1 (Richmond Hwy) corridor. These narratives will include thematic approaches to identified significant sites as provided by FCDOT and include Mount Eagle, historic motel and commercial structures along Route 1, Beacon field, Historic Groveton, Huntley House, and the original Mount Vernon High School among other sites. This project will include a public input component and is slated for completion in Fall 2023.
- **Goins House Update:** The Goins House will be going to the Board of Zoning and Appeal on January 25; due to time and financial constraints, DPD Heritage Staff have recommended Phase II architectural documentation and for funding for a wayside marker. The applicant was amenable to the requests.
- **National Trust Membership Renewal:** Motion needed to approve \$250 to renew the History Commission's National Trust Membership.
