## Proclamation Highlighting Houselessness and Hunger

Whereas every child deserves a safe, stable, nurturing and nourishing environment to call home in which they can thrive and reach their full potential, houselessness and hunger among students is a pressing issue in our country, state, and most importantly, in our community due to factors of rising food costs, interest rates and rents, the rate of evictions have <u>doubled</u> and hunger has surged; houselessness and hunger affects the social and emotional well-being of students, deprives a sense of belonging, leads to learning loss, and has numerous cascading effects; and

Whereas one in every eight children in this country experiences food insecurity, the expiration of COVID-19 supports such as Child Tax Credits (CTC), universal meals, and reductions to Supplemental Nutrition Assistance Programs (SNAP) have caused hunger to increase, and student hunger negatively affects the ability to learn and knowledge retention, often facing lower academic achievement and a higher likelihood of school

absenteeism; student hunger and houselessness disproportionately affects communities of color; and

Whereas houseless students face unique challenges, which are not limited to housing instability, a lack of access to basic necessities such as food, attendance and disruption to their education; moreover, these 2,300 students demonstrate remarkable resilience, strength, grit, and determination in the face of adversity, inspiring us all with their courage and tenacity; and

Whereas, educators, support staff, community organizations, and volunteers play a critical role in providing assistance, support, and resources to homeless students, helping them navigate the challenges they face; dedicated staff of Special Services has a long history of service of providing resources such as Weekend Food Backpack Program, Coats for Kids, Back-To-School Basics, and housing in partnership with community-based organizations to address the unique challenges faced; and

Whereas, addressing homelessness and hunger requires a comprehensive and compassionate approach that includes collaboration among government agencies, affordable housing developments, non-profit organizations, community leaders, and concerned citizens; let us promote empathy, understanding, and compassion for houseless students and families by working towards creating a society where no family is left without a home or food for their family by building affordable housing for all; and

NOW, THEREFORE, BE IT RESOLVED that Fairfax County School Board recognizes Hunger and Homelessness Week which is observed annually during November 11 to 18 as a time to highlight the promoting compassion, solidarity, and sustainable solutions to combat hunger and homelessness in our community, and to encourage coordinated efforts to make a positive impact.
