Approve December 13, 2022 Meeting Summary

The committee approved the December 13, 2022 CCFAC Meeting Summary, as corrected.

Review and Approve the Release of Draft FY 2024 One Year Action Plan, WAG Recommended Allocation of Federal Resources in FY 2024, and Related Contingency Plan for Public Comment

B. Beverly provided an update to the committee on the status of the Draft FY 2024 Action Plan and related funding allocations documents. Once approved by the committee, the Draft FY 2024 Action Plan public comment period will be from February 9 through March 21, 2023. CCFAC will have an additional opportunity to discuss public comments and review changes to the Draft FY 2024 Action Plan during the April 11, 2023 CCFAC meeting. For easier review, a member requested that DHCD staff provide a glossary list of all acronyms found in the draft Action Plan.

The committee approved the release of the Draft FY 2024 One-Year Action Plan, WAG Recommended Allocation of Federal Resources in FY 2024, and the related Contingency Plan for public comment.

Review and Discuss CCFP Community Engagement Results

C. Rankin and R. Carroll provided the committee with a summary of results from the Consolidated Community Funding Pool (CCFP) Funding Categories Funding Cycle for FY 2025-2026 community engagement results. The survey was open from December 5, 2022 through January 4, 2023. There were 611 responses received from all parts of the county.

Chairperson Blum reported that the Health Care Advisory Board (HCAB) received a briefing from Department of Family Services (DFS) staff on the unwinding of the continuous Medicaid enrollment during COVID that will soon end this Spring.
