- ❖ Cable hook-up in each room (residents pay for cable service and WI-FI)

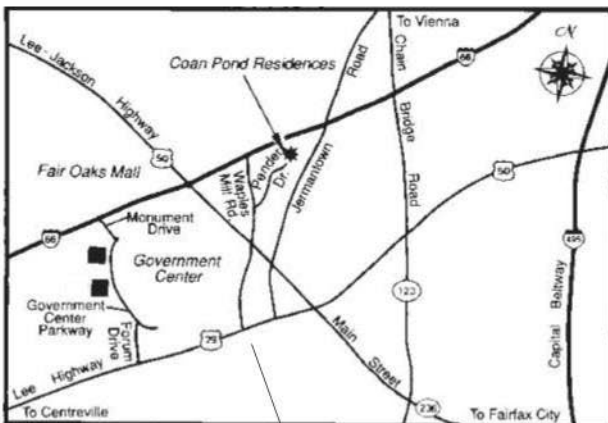
Other Amenities Include:

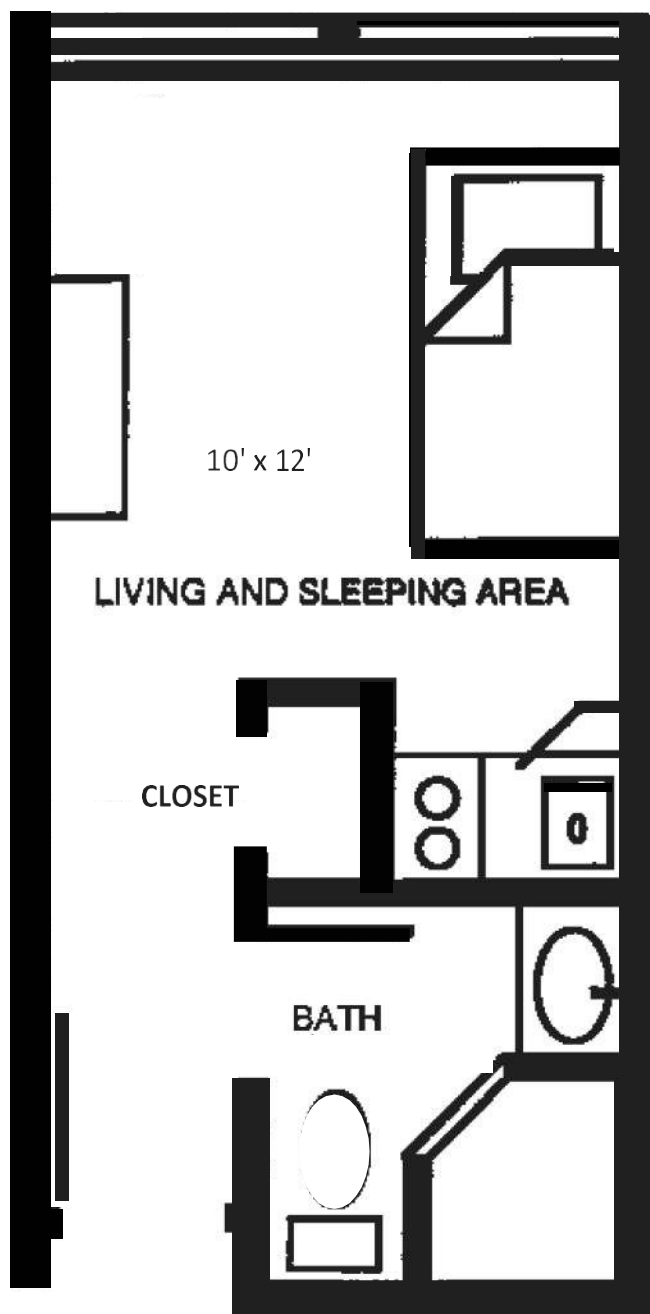
