# Live Well Program Fitness Pass Application for Fairfax County Government Benefits Eligible Employees and Retirees

Fairfax County provides a subsidy towards the purchase of a 6, 12-month or 25 visit Fast Pass Fairfax County Park Authority Fitness Pass. The subsidy is available through the Live Well Workforce Wellness Program for benefits eligible employees and eligible retirees. The 6 and 12 month passes provide admission to all 9 FCPA RECenters and the Employee Fitness and Wellness Center. The 25-visit Fast Pass provides admission to all 9 FCPA RECenters ONLY. The Fast Pass admissions are good for up to 2 years. Please allow 5 – 7 business days for processing of all pass types. Passes are not eligible for refunds, holds or extensions.

To purchase a pass, indicate your desired pass type with a check mark in the table below. Note: If both spouses are Fairfax County Government benefits-eligible merit employees or retirees, use the section labeled '2 Eligible Fairfax County Employees'. Although dependent passes do not receive a discount, you may purchase dependent passes at this time. Enter the quantity of dependent passes to be purchased.

- \* To qualify for the senior rate, the senior must have reached age 65 as of the purchased date.
- \*\* The age for dependents is 5 – 18 years of age. Students aged 19 – 24 may also qualify, if a full-time student.
