Dear *Innovation Challenge* Participants:

The "One Fairfax" Resolution, approved last summer by the Board of Supervisors, strives to build an opportunity-rich society for all, in part by providing vital heath and human services to residents in need. We know that when everyone in our community has the chance to fulfill his or her potential to the maximum extent possible, everyone among us benefits.

Like many jurisdictions across the country, Fairfax County must find novel and innovative ways of funding and delivering essential

services. Demand is outstripping resources and is becoming more complex. The "*Human Services Needs Assessment*," published last year, makes clear we must embrace change in the way we deliver, pay for and evaluate the programs and services that so many people need. To that end, and as a first step, we have begun a five-year program to modernize and streamline our IT program to dramatically reduce paperwork and delays for service recipients, and to better measure program outcomes.

Today's community-driven "Innovation Challenge" led by residents is unprecedented in that it brings together leaders of all the elements of the emerging 21st Century human services community: businesses, established and startup; financiers in social impact investment; social entrepreneurs; philanthropists and foundations; nonprofits; and outstanding thought leaders in academia. Fairfax County's employees are here primarily to *listen*.

While it remains to be seen what may emerge from this initial endeavor, I assure you the Board of Supervisors is open to lending its support to initiatives that enhance collaboration among the private and public sectors and academia, both in terms of funding and service delivery. This is the future of human services, and we are eager to participate.



Innovation Challenge

Over time, and for a variety of demographic and economic reasons, gaps and stresses in the region's health and human services programs have become evident and are growing. In 2016, a Human Services Needs Assessment found, among other things, that children, older adults, and individuals with disabilities are particularly challenged in reaching their full potential. Given limited resources and growing needs, it is imperative that community leaders seek creative and innovative approaches for more effective service delivery.

The Innovation Challenge, hosted by the Human Services Council, is a series of events to discover socially innovative solutions to address community challenges in Fairfax County. This initial kickoff event has three objectives:

- Exchange information about state-of-the art innovations that can address health and human services challenges.
- Elicit new ideas from public and private partners to enhance services and maximize resources.
- Set the stage for specific recommendations about service enhancements and resources required to present to relevant stakeholders in the future.

The Human Services Council anticipates that participants will:

- Learn about innovative models and strategies that may be useful in our community.
- Network to explore new partnerships.
- Be excited to participate in future events to continue the exploration of social innovation in health and human services in Fairfax County.

Sallie Keller, Ph.D., is professor of statistics and Director of the Social and Decision Analytics Laboratory at the Biocomplexity Institute of Virginia Tech. Dr. Keller's prior positions were Academic Vice President and Provost at University of Waterloo, Director of the IDA Science and Technology Policy Institute, the William and Stephanie Sick Dean of Engineering at Rice University, head of the Statistical Sciences group at Los Alamos National Laboratory, professor of statistics at Kansas State University, and statistics program Director at the National Science Foundation. Dr. Keller has served as a member of the National Academy of Sciences Board on Mathematical Sciences and Their Applications, the Committee on National Statistics, and has chaired the Committee on

Applied and Theoretical Statistics.

Areas of expertise are social and decision informatics, statistical underpinnings of data science, uncertainty quantification, and data access and confidentiality. Dr. Keller is fellow of the American Association for the Advancement of Science, elected member of the International Statistics Institute, fellow and past president of the American Statistical Association, and member of the JASON advisory group. JoAnn K. Barnes has served Montgomery County residents through the Department of Health and Human Services (HHS) for almost thirty years. She joined the Department as the Finance Officer. She holds a B.S. degree in Accounting, is a licensed CPA and is a candidate for a Masters of Human Services scheduled to graduate in June 2017. As Finance Officer, Ms. Barnes provided oversight to Montgomery County's transition from Food Stamps to Electronic Benefit Transaction cards and managed the issuance of cash assistance, food stamp and medical assistance benefits. Ms. Barnes moved into HHS' direct services programs as the manager of the Welfare to Work program. Her portfolio grew to include child care subsidies and all public assistance programs. In January 2011, she became the Deputy Chief

of Children, Youth and Family Services and today serves as the Chief of that service area at HHS. In this role, Ms. Barnes oversees Early Childhood Services, Child Welfare Services, Child and Adolescent Services, Eligibility Programs, and Positive Youth Development and manages a team of 540 staff and an \$82 million budget.

During her career at HHS, Ms. Barnes implemented two neighborhood service sites during the recession, partnering with non-profits to bring services into neighborhoods affected most by the economic downturn. She also implemented a customer service pilot that has evolved into staff-led quality improvement teams at each of the HHS regional offices.
