Dear Neighbors,

Greetings from your Hunter Mill District member of the Fairfax County Board of Supervisors! To complement our regular digital communications, I'm taking this opportunity to send an old school newsletter with information I believe you'll find useful. In addition to a breakdown of the 2020 Census, this issue serves as a consolidated resource for accessing key government services and your elected officials. One of my most important responsibilities as supervisor is connecting you with the right person to address problems and concerns. I recommend keeping this mailer handy for easy reference.

As you may already know, Hunter Mill District is one of nine supervisory districts in Fairfax County, and each district elects their own supervisor and a Board chair is elected countywide. Fairfax County provides many key local government services including planning and zoning (outside of town boundaries), libraries, human services, mental health services, fire and rescue, affordable housing, public safety, the Fairfax County Park Authority, the Fairfax Health Department, solid waste disposal and recycling services, water and sewer services, and most of the funding for our public schools.

There are several things that make our district special and why I've called Hunter Mill District home for many years. We are an engaged community that cares deeply about our quality of life and helping each other. Who We Are

Fairfax County is nationally known for our strong economy, vibrant and engaged neighborhoods, and a diverse, high-achieving public school system. Our diversity enriches our local culture and makes our area even more attractive in a globalized economy. Hunter Mill District is all this and more, a growing and thriving community with a rich history and a bright future. The 2020 Census gave us a great snapshot of how we identify and where we come from – here are some highlights:

Fairfax County has a minority majority population of 1.15 million:

- Non-Hispanic White alone: 47.1%
- Non-Hispanic Asian alone: 20.3 %
- Hispanic or Latino: 17.3 %
- Non-Hispanic Black or African American alone: 9.4%
- Non-Hispanic Population of two or more races: 5%
- Non-Hispanic Some other race alone: 0.6%
- Non-Hispanic American Indian and Alaska Native alone: 0.1%
- Non-Hispanic Native Hawaiian and Other Pacific Islander alone: 0.1%

Hunter Mill District's population grew 5.7% since the 2010 Census to 129,651 residents:

- Non-Hispanic White alone: 57.2%
- Non-Hispanic Asian alone: 18.8 %
- Hispanic or Latino: 11.1 %
- Non-Hispanic Black or African American alone: 6.8%
- Non-Hispanic Population of two or more races: 5.4%
- Non-Hispanic Some other race alone: 0.7%
- Non-Hispanic American Indian and Alaska Native alone: 0.1%
- Non-Hispanic Native Hawaiian and Other Pacific Islander alone: 0.04%

County staff will use these and additional data to create an updated Demographics Report. Once it is released this spring, I will include a link in my weekly newsletter. It will also be available by searching "demographics" at fairfaxcounty.gov.



Fairfax County Public Schools (FCPS) is the 11th largest school division in the United States, with more than 178,000 students in grades PreK-12, speaking over 200 languages, and learning in 198 schools and centers. One of the largest employers in Virginia, FCPS has nearly 25,000 full-time employees, of whom 93% are school-based. FCPS helps Fairfax County be an employment and economic engine.

FCPS remains focused on inspiring and empowering students to meet high academic standards; lead healthy, ethical lives; and be responsible and innovative global citizens. I am eager to see the development of plans to use the Science of Reading for reading instruction, that maximizes how the brain learns literacy. 
