# Hunter Mill Highlights from Supervisor Cathy Hudgins



Dear Hunter Mill Friends,

Recently, Alex Koma, a reporter from the Washington Business Journal called. He wanted to talk about the 20 years of economic development during my term as the Hunter Mill District supervisor. Has it really been 20 years, I wondered, as I started a mental review of what turned out to be, indeed, a combination of years working with land use planning, market forces, and economic growth. What follows are my reflections that were shared with him.

As a single factor driving the activity of so many other entities, I must acknowledge the significant fiscal change that the Metro Silver Line extension produced. This economic engine, as part of a greater transit network, connects Dulles International Airport, Washington, D.C., and Baltimore Washington Airport – depart locally and arrive internationally. Weekly, new businesses make Reston their headquarters because they can attract a labor force that can take light rail to work. Moreover, this high-tech corridor rivals Silicon Valley. We are home to many large corporations like General Dynamics, Google, Oracle, Bechtel, Leidos, and Deloitte.

Riding on Metro to WMATA meetings, I observe and join federal employee commuters travel avoiding traffic delays and hassles during peak rush hour congestion. Visitors and tourists can enjoy an eco-friendly trip to the D.C. attractions.

Additionally, since the arrival of Metro, the presence of transit - oriented development (TOD) of commercial, retail, and residential sites in the Transit Station Areas (TSA) is clearly visible. Construction of the Jahn Building with its distinctive design and lighting and the blue EXO building with its light responsive, color-shifting exterior are two excellent examples. As part of Reston Station, the BLVD apartments with an almost immediate Metro access, combine TOD living and the park like environment of Reston.

Take a look at what the near future will bring. The Halley Rise area will host a movie theater, public art, and a Wegmans. Also coming soon is a Marriott Hotel at Reston Station. Finally, let's not forget the new drive-through Wiehle Avenue Fire Station 25 scheduled to be completed late 2021.

With the next six stations to Dulles Airport opening next year; the Silver Line is absolutely an economic boon to the Hunter Mill District and the entire Dulles corridor. I am proud to be associated with it.

## School Bond Referendum

A \$360 million school bond referendum will be on the November 5, 2019 general election ballot. If approved by voters, Fairfax County Public Schools plan to sell bonds to pay for:

- Planning and/or building two new elementary schools (locations to be determined)
- Renovating 10 elementary and two middle schools
- Building additions at three high schools
- Relocating one modular building.

Planned projects will increase capacity of school buildings countywide by more than 4,400 students.

### 2020 *Shape the Future of Aging*. 50+ Action Plan Develops

The Fairfax Area Commission on Aging earlier this year undertook a 50+ Community Survey for Fairfax County and the Cities of Fairfax and Falls Church. The survey received a 22% response rate and the demographics of survey respondents were very much in line with the area demographics. The respondents were asked to rate the following:

- Safety and health
- Housing
- Transportation
- Community Engagement
- Services for Older Adults and Family Caregivers
- Employment and Retirement.

The information from the survey will be used to create a 2020 Action Plan that will update the existing 2014 50+ Action Plan. The 2020 Action Plan will focus on the 5 categories listed below:

- **S**ervices for older adults and family caregivers
- **H**ousing and neighborhood supports
- **A**ccess to mobility options
- **P**ersonal well-being
- **E**conomic stability and planning.

These categories align with Fairfax County Strategic Plan that is currently underway. The results of the survey and ideas about the 2020 Action Plan will be presented at a Public Forum that will be scheduled in the next several

### Public Meeting For Your Ideas on Transportation Initiatives

The Commonwealth Transportation Board (CTB) invites the public to share feedback on transportation initiatives at meetings across Virginia this fall. Representatives from the Office of Intermodal Planning and Investment (OIPI), the Virginia Department of Transportation (VDOT) and the Department of Rail and Public Transportation (DRPT) will highlight transportation programs, discuss ideas and answer questions about the Commonwealth's multimodal transportation network. The local meeting will be on **Tuesday, October 22**, 6pm, at the Northern Virginia District Office (4975 Alliance Drive, Fairfax 22030).

The public will have an opportunity to learn and share feedback about:

- Adjustments to the statewide project prioritization process, known as SMART SCALE, which allocates limited funding to the most critical transportation needs.
- Virginia's Statewide Transportation Improvement Program, which identifies transportation projects that will utilize federal transportation funding or require approval from federal partners.
- A draft Mid-term Transportation Needs assessment for VTrans, Virginia's statewide, multimodal transportation plan that outlines a vision and goals for transportation in the Commonwealth. The plan will identify transportation investment priorities and guides transportation agencies' strategies and programs.
- Adjustments to Virginia's Highway Safety Improvement Program, which aims to link infrastructure improvements across highway travel modes to performance outcomes outlined in Virginia's Strategic Highway Safety Plan.

### Application Withdrawn

**ORR-BSL Hunter Mill, LLC** filed Special Exception (SE 2018-HM-024) for a proposed assisted living facility at 2347 Hunter Mill Road [Tax Map 37-2((1)) Parcel 26]. The two-story building with a cellar will contain approximately 43,680 square feet of gross floor area. The proposed building height is approximately 38 feet and will comprise of single and double occupancy rooms with a maximum of 86 beds. Approximately sixty surface parking spaces will be provided for residents, staff and visitors. **This application was officially withdrawn on Tuesday, October 1, 2019.**

### Applications Approved

**American Armed Forces Mutual Aid Association** filed Proffered Condition Amendment (PCA 78-C-098-04) and Final Development Plan Amendment (FDPA 78-C-098-05) to replace the existing three-story office building with two three-story campus-style office buildings at 1850 Old Reston Avenue, [Tax Map 17-4 ((1)), Parcel 1]. The property is located on the west side of Old Reston Avenue, north side of W&OD trail, and south of Temporary Road. The existing historic A. Smith Bowman House listed on Fairfax County Inventory of Historic Sites will not be disturbed, in addition, the pond and gazebo are preserved. **The Planning Commission recommended approval at their July 31, 2019 meeting. The Board of Supervisors approved this application at their September 24, 2019 at meeting.**

**Golf Course Overlook, LLC** filed Rezoning/Final Development Plan (RZ/FDP 2016-HM-016) for 11480 Sunset Hills Road, Reston [Tax Map 17-4 ((5))S6] to rezone from Industrial 5 (I-5) and Residential Estate (R-E) to PRM to permit a high-rise residential building containing 413 multi-family units and approximately 1,000 square feet of permitted secondary uses to serve residents. **The Planning Commission public hearing is scheduled for September 19, 2019 at 7:30pm. The Board of Supervisors approved this application at their September 24, 2019 .**

**Srinivas Akella, Krishna Kidambi and others** filed Proffer Condition Amendment (PCA 1998-HM-036) to revise proffer number 10, accepted in 1999, in order to permit modification of terms of the required landscape easement located between Lawyers Road & the subject properties. **This application was expedited and the Board of Supervisors approved this application at their September 24, 2019 meeting.**

### Applications Scheduled: *(Staff report is posted 2 weeks prior to the Planning Commission hearing.)*

**NS Reston LLC** filed a Conceptual Plan (CP 86-C-121-15) and Planned Residential Community application (PRC 86-C-121-06) to permit construction of a multifamily residential building on the north side of New Dominion Parkway, [Tax Map 17-1((17) Parcel 4]. The building is planned to be 13 stories and will consist of approximately 127,855 square feet of gross floor area. A three-level underground garage will have 131 parking space, with six (6) surface parking spaces near the main entrance. **The Planning Commission recommended denial of this application at their June 19, 2019 meeting. The Board of Supervisors held the public hearing for this application on September 24, 2019 and deferred decision until October 15<sup>th</sup>. However, the application is now being re-advertised, and a new public hearing is scheduled for Tuesday, October 29, 2019 at 3:00 p.m. [Additional information online](#) and at [PRC 86-C-121-06](#)**

**APA Properties No. 6, LP** (Isaac Newton Square) filed rezoning application (RZ 2018-HM-020) to rezone from Industrial District-5 to Planned Residential Mixed-Use (PRM), [Tax Map 17-4 ((5)), parcels 3C1, 3E1, 3N1, 3W2, 6S2, 6S4, 7E2 and 7N2]. The property is comprised of eight parcels equaling 32.14 acres. The proposed neighborhood will comprise up to 2,828,884 square feet of uses (inclusive of any bonus density units), including 2,500,000 square feet of residential uses, 68,884 square feet of retail uses and 260,000 square feet of office uses. Applicant proposes up to 2,100 residential units, to include 14% workforce dwelling units and where applicable, Affordable Dwelling Units (ADU). Planning Commission public hearing is to be determined after Traffic Impact

Analysis (TIA). The **Planning Commission recommended approval on September 19, 2019. The Board of Supervisors public hearing is scheduled for Tuesday, October 15, 2019, at 3:30pm.** [Additional information online](#)

**1900-02 Campus Commons, LLC** filed a Rezoning and Development Plan (RZ/FDP2017-HM-018) and Proffer Condition (PCA 79-C-023) Amendment for approximately 11.6 acres at 1900 – 1902 Campus Commons Drive [Tax Map 17-4 ((1)) Parcels 33 and 34] at the corner of Sunrise Valley Drive and Campus Commons Drive. The Applicant is seeking a mix of residential units and retail space, in addition to maintaining the existing office buildings. Two development options are being proposed: (1) an additional 1,182,435 to 1,183,635 square feet of residential gross floor area with up to 1,097 residential units, and (2) between 18,480 and 26,480 square feet of ground retail. This is inclusive of the existing 233,390 square feet of office and 1,980 square feet of retail, with a combined total of 1,419,005 square feet of development. **The Planning Commission public hearing was held September 25, 2019, however, deferred decision until Thursday, October 10, 2019. **Blue Ocean Development, Inc.** filed Special Exception Amendment (SEA 2013-HM-012) for the property located at 1283 Serenity Woods Lane, Vienna [Tax Map 19-1 ((01)) Parcel 27A]. The Applicant proposed to demolish an existing structure located on the property that is in poor condition and construct a new single family dwelling that will more properly fit within the character of the surrounding community. **The Planning Commission recommended approval on September 25, 2019. The Board of Supervisors public hearing is scheduled for Tuesday, October 15, 2019 at 4:30pm.** [Additional information online](#)

**CRS Sunset Hills, LC (Reston Promenade)** has filed Proffer Condition Amendment/Conceptual Development Plan Amendment and Final Development Plan Amendment (PFC/CDPA/FDPA 2016-HM-035) to refine "Building C" of A-D to reflect the needs of a premier hotel and potential retail tenants, improve the overall layout and design, improve pedestrian connectivity and porosity, create a more seamless circulation within the property, and enhancements to the urban parkland serving the project. The property is located at 1830 and 1860 Wiehle Avenue [Tax Map 17-4 ((1)) Parcels 20, 17B, 14A and a portion of 17A]. **The Planning Commission public hearing is scheduled for Wednesday, October 16, 2019 at 7:30 p.m. The Board of Supervisor public hearing is scheduled for Tuesday, October 29, 2019 at 3:30pm.** [Additional information online](#) and [CDPA 2016-HM-035](#) and [FDPA 2016 - HM-035](#)

The maximum building height in Option II is increasing from 95 to 110 feet. The primary change requested is an altered site design along the eastern property line in order to construct an interim section of Boone Boulevard. **The Planning Commission recommended approval at their October 2, 2019 meeting. 
