July 15, 2020:

-Criminal trial dates begin every Wednesday

General:

Format: Continue with remote/telephone hearings except as determined by the presiding judge

or criminal trials in which the defendant requests a full hearing, in person

COVID-19: Continue recommended safety precautions including social distancing in and out of the

courtroom; mandatory wearing of face masks and hand washing

Promote: Parties are encouraged to participate in mediation; enter settlements and other agreed

orders as the court resolves the backlog of cases continued due to the pandemic

Pending cases: The clerk's office shall continue all cases currently set in June 2020 through September

30, 2020.

The clerk's office shall reschedule all civil and criminal cases, originally set for trial in March, April, and May 2020, which were continued due to COVID-19, for a status hearing beginning the week of July 6, 2020

All cases involving petitions filed by the Fairfax County **Department of Family Services (DFS)** shall **remain on the current docket as scheduled**, unless approved by the Chief Judge, due to federal and state timeline requirements. These cases shall be **heard by the trial judges**. If the case can be heard by the regularly assigned judge (One Judge; One Family), it shall be so assigned. If not, any trial judge may hear the case.

Criminal and civil cases in which the **defendant/juvenile is detained shall be given priority in rescheduling**

CC Judge: Beginning on June 15, 2020: Daily from 9:00 -10:00 A.M, CC matters will be heard by

Team A/Team B on an alternating basis until July 2, 2020

Beginning on July 6, 2020, CC matters will be heard on an alternating basis by all 8

judges daily

SH Additions: Beginning on July 6, 2020, all cases will initially be set for a status hearing only for both

civil and criminal cases. Cases will be scheduled based upon the date of filing

DCSE: DCSE requests all hearings be held via remote/telephone only. **DCSE cases will be heard**

every Friday instead of the SHI AM Docket

Civil Trials For SHI/DCSE cases, it will be difficult to practice "One judge, one family." However,

when a trial date is set, the court will strive, when possible, to set the trial with the

assigned judge, particularly for modifications
