 Plantings are established at the correct depth and width—root flare is exposed (Figures 1 & 2) per ANSI A300.6. PFM 12.03104E
 Burlap and at least 1/2 of the wire basket are removed (if used) per ANSI A300.6 (Figure 1). PFM 12.0505.3
 All plantings are <u>ALIVE</u> and in good condition per ANSI Z60.1. Replace any dead or dying. PFM 12.05051D
 All plantings are the same SPECIES and SIZE (per ANSI Z60.1) as noted on the approved site plan. Substitutions can be made through the proper procedure with FCON. PFM 12.0505.1A
 Staking (per ANSI A300.6), if necessary, is completed with ArborTie® or equivalent. Hose & Wire will not be accepted. PFM 12.0505.3C
 Pruning cuts follow ANSI A300.1. PFM 12.0506.5
 Plantings are not in easements, are at least four feet from signs, and are the prescribed distances from transformer boxes. At the time of installation, if conflicts between plantings and site utilities arise, minor shifts in planting location may be acceptable upon notice to FCON. ANSI A300.7. PFM 12.0315.5






