Dear Mr. Rieger:

The referenced Water Quality Impact Assessment (WQIA), revised September 12, 2023, has been administratively reviewed for completeness in advance of the required submittal of a Resource Protection Area (RPA) exception request (WRPA) under Section 118-6-1 of the Chesapeake Bay Preservation Ordinance (CBPO), and has been found to be acceptable for inclusion with the WAIV submittal.

A CBPO Article 6 WAIV submittal is required to formally initiate the process for requesting a Public Hearing with the Exception Review Committee. To complete your application, please submit the following as a WAIV in PLUS:

- 1. A digital copy of the Article 6 Application Form; Exception for Public Hearing (RPA) (fairfaxcounty.gov). Please complete all of parts 1, 2, 3, 5 and 6. Only complete the relevant sections of part 4, (specifically do not complete the parts referencing sections 118-6-5, the submission requirements); 118-6-5.a.
- 2. A separate digital copy of the plat, page 9 of the WQIA, which shows the limits of disturbance; 118-6-5.c.
- 3. Photographs of the property showing existing structures, and terrain and vegetation; 118-6-5.d.
- 4. A map identifying a map identifying classification of soil types, at a scale of one inch equals 500 feet, covering an area at least 500 feet beyond the perimeter of the proposed development; 118-6-5.e.

5. A statement of justification which addresses how the proposed development complies with the factors set forth in CBPO 118-6-5(a) through (f) items (*To avoid duplication, references may be made to specific sheets/pages and paragraphs in the subject WQIA submission.*); 118-6-5.f.

The WAIV submittal is expected within 14 days of the date of this letter. Please submit your application through <u>PLUS</u>.

<u>Please do NOT</u> resubmit a duplicate copy of the WQIA. The subject WQIA stamped in <u>PLUS</u>, accepted for public hearing, will be used to complete the exception package; 118-6-5.b.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, FFX - LDS (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
