I hope this message finds you well. We have reviewed the RPA exception request and identified a discrepancy in the RPA delineation on the plat attached to WAIV-2023-00514, as it does not align with the approved 9820-RPA-001-1. It is crucial that we address this issue promptly.

Attached, you will find an approximate location of the revised RPA line per 9820-RPA-001-1. Please review it at your earliest convenience. We are unable to proceed with accepting the package until the RPA delineation is rectified.

It's important to note that the revised RPA delineation may have implications, particularly concerning the 800 SF encroachment, which might fall within the 50 ft seaward. Your attention to this matter is greatly appreciated.

I am available for a brief meeting tomorrow between 10 am and 12 pm, as well as from 2 pm to 3:30 pm. Please let me know which time slot suits you best for further discussion on this issue.
