Thousands of kids pass by this location going to and from school by walking, bike, car and school bus every day. The facility is right in the middle. MHS students could potentially (i) bring students easy access to drugs, through their voluntary or involuntary encounters/interactions with the patients or visitors of the treatment center; (ii) send wrong messages to students that doing drug is not a big deal as there are easy remedies such as treatment centers right in the neighborhood.</p> <p>2. The facility, if built, would increase the already crowded traffic on Davidson Road leading to MHS. The planned facility is located at a three-house compound. Davidson Road is a narrow two-way road with one lane each way. It connects to the busy Chain Bridge Road with only a stop sign at the intersection. Most of MHS's 2000 students going to and from the school on Davidson by walking, bicycle, car and school bus every day. The new operations would cause substantially more traffic, increase safety risks to students and disruptions to school activities.</p> <p>3. Monroe has not shown any interest in working with the community. It did not even notify MHS or neighbors around there, other affected community members Monroe's real estate broker was subject to a non-disclosure agreement and did not inform sellers of the properties' intended uses. Monroe started the construction, including put fences, renovation, etc., without notifying neighbors. It was only when residents in the neighborhood saw where green space previously existed turned into parking lots that they realized something unusual was going on. We understand that MHS or its PTSA were not notified about the plan or were consulted either, there is no public hearing about it.</p> <p>4. Monroe did not have a good reputation in managing its facilities in other locations. It was disturbing to learn residents complained about the company's other site in Connecticut. (See https://www.wfsb.com/news/neighbors-raise-concerns-about-school-for-troubled-youth/article_231fc9cd-f594-5cfe-9d0c-c4dfc0903aa6.html). Complaints include, among other things, runaway patients, increased crime, heavy traffic and noise also caused by increased ambulance and police vehicles called to service.</p> <p>We are therefore deeply concerned about the proposed facility at this location, and sincerely ask you to help stop the plan by rejecting the license request.
