# **Our Identity**

#### Staff and Volunteers

**Staff** – Library staff are crucial to our success. We work beyond the walls of our individual branches, providing outreach to schools, senior centers, civic organizations, non-profits and other neighborhood organizations. Our staff go to these places not just as emissaries of library service, but to assist others where they are. Library staff use their tangible skills and know how to navigate an increasingly complex world of information whether it be in the physical or the digital form.

FCPL staff give invaluable feedback on how to make the library more efficient and help chart the many changes the library has undergone through the years. They ensure the library is a safe place to learn, create and explore where all people are welcome.

**Volunteers** – Each volunteer hour is meaningful and brings a special gift to the library. Our volunteers are effectively involved in the delivery of quality library service and support the library's mission and objectives. Our needs are matched with their skills whether for a few hours on a one-time project or for years as a veteran volunteer. Each year, hundreds of individuals and corporate volunteers donate thousands of hours of their time to the library.

We are continually amazed and astounded by the dedication and commitment of our volunteers. They provide immense benefits throughout the library system as they work behind the scenes processing mountains of books; diligently spend hours getting and keeping our books in order; preserve the history of our county; and enthusiastically introduce children to the wonders of reading. ### Intellectual Freedom and Equal Access

Free communication is essential to the preservation of a free society and a creative culture. Librarians have a profound responsibility to protect that freedom by making it possible for readers to choose freely from a variety of offerings. FCPL supports intellectual freedom through a commitment to facilitating open public access, privacy and an extensive range of constitutionally protected information, ideas, opinions, perspectives and viewpoints. Attempts to restrict or prevent access to library materials are a denial of the fundamental premise of democracy. To that end, we affirm the following principles<sup>1</sup>:

- We protect everyone's privacy and confidentiality in the use of library resources and services, including children and teenagers.
- We affirm the responsibility and the right of all parents and guardians to guide their own children's use of the library and its resources and services.
- We connect people and ideas by helping each person select from and effectively use the library's resources.

By embracing these principles, FCPL contributes to a future that values and protects freedom of speech in a world that celebrates both our similarities and our differences, as individuals. Librarians have a profound responsibility to advocate for that freedom and provide a variety of offerings that embrace diversity of people, opinion and thought. FCPL trusts our users to make their own decisions about what they read and believe.

Intellectual freedom is a core value of the library profession and a basic right in our democratic society. We adhere to professional ethics and standards for public libraries and support the ALA Library Bill of Rights, and the statement that "Libraries should challenge censorship in the fulfillment of their responsibility to provide information and enlightenment." Publicly supported libraries provide free, equitable and confidential access to information for all people in our community.

### Diversity and Inclusion

Libraries play a crucial role in serving diverse community members with varying needs and interests. FCPL strives to be a key part of the rich resource landscape in which our residents and families live, work, play and learn. We work to reflect our nation's diversity by providing a full spectrum of resources and services, recognizing that equity, diversity and inclusion (EDI) impact all aspects of life with the communities we serve. Public libraries occupy a unique position to provide access to resources and the guidance to navigate those resources independently.

Libraries respect that individual needs vary based on many facets, including race and ethnicity, age, income, physical limitations, religious beliefs, education, language, affiliations, sexual orientation, gender identification or geographic barriers. As

facilitators of the public's access to information and materials without prejudice, we ensure all library resources are available to each member of the community. In alignment with Fairfax County's One Fairfax policy, the library prioritizes equity, diversity and inclusion (EDI) in our organizational values, strategic planning and key initiative areas.

Communities draw strength from differences that bring valuable perspectives, experiences and knowledge to a more inclusive community. FCPL ensures the availability of resources and services for those who may be under-represented, marginalized or excluded from participation. Now, more than ever, we intend to preserve and strengthen our core values of intellectual freedom and equal access to information, as well as the stewardship and accountability of the public resources entrusted to us.

#### Physical vs. Digital

FCPL works to balance the physical with the digital in an ever evolving world. We are adapting and energizing library spaces and resources. We keep up with the needs and interests of our users by offering changing services and programs. The library offers the unmatched nostalgia of a trusted and familiar space with the lure of holding a physical book so reassuring to many library users while also offering the ease of accessibility and availability of digital collections and resources.



Our challenge is to connect the physical space of the library with the digital space of information and communication. Leveraging their strengths and experimenting with the ways they can complement each other, we are reimagining what the library of the future will look like.

Library users require and demand a mix of both physical and digital experiences, each complementary in nature. These transitions will continue to become more seamless and effortless in the future. Technology will enable this, and libraries are adapting, adopting and creating new opportunities.



#### **Digital Equity**

FCPL bridges the digital divide by providing internet access and offering digital skills programs. Library users build their technology skills through events and online learning resources. All online content is available at no cost with a free library card. Our role in helping achieve this vision became even more visible during the COVID-19 pandemic, as people were encouraged to visit public library parking lots where we extended wireless internet access while the buildings were closed.

The library plays a key role in promoting Fairfax County's ideal vision of digital equity including::

- Affordable digital hardware and connections
- Awareness of digital resources and services
- Access to specific digital tools
- Advancement of digital literacy skills

Without digital inclusion, the expansion of technology becomes another barrier to entry and participation whether as a student seeking educational opportunities, as an empowered employee in the job market, or simply engaging with others online. Technology impacts our daily experience, and the library is assisting through new and established partnerships, and our expanding knowledge and resources.
