



Tuesday's Board of Supervisors (BOS) meeting opened with a rousing performance by the **U.S. Army Old Guard Fife and Drum Corps**. This presentation marked the Board's designation of June 22 - 29, 2019, as **Army Week** in the County. The relationship between the U.S. Army and Fairfax County is **important and integral to both organizations**, and it has been a pleasure to **collaborate with Garrison Commander Col. Michael Greenberg**. As the **largest employer** in the County, **Fort Belvoir is a valuable partner** to the Mount Vernon District. In addition to being a good

neighbor, Fort Belvoir provides a large community hospital, the location for the Eleanor Kennedy Shelter, and we look forward to the opening of the National Museum of the United States Army (NMUSA) in 2020. As we continue to look for ways for the community, County and Garrison to work together, Intergovernmental Support Agreements (IGSA) are one way we can do this and also increase support for local businesses. A special thank you to all who serve, and their families who support them.

The Board recognized the **50th Anniversary of the Fairfax County History Commission** and received its **Annual Report**. The Mount Vernon District is well
represented on the Commission by local historians and
residents **Glenn Fatzinger**, **Sallie Lyons and Anne Barnes**. These individuals also serve the District and
preserve our history through the **Mount Vernon History Commission**. Among other things, the Commission
regularly hosts historic events, including "**Historic**

The BOS also recognized **Charles "Chuck" Murray** for his years of service as General Manager of the **Fairfax Water Authority**. Not only is Chuck **nationally known** throughout the water industry, but he is largely responsible for the **Vulcan Quarry project** which has assured a **quality water supply for the County** into the next century. Chuck led the **10 year process** and oversaw the many varied details to bring this **complex project to fruition**.

During the meeting, the Board approved a **Memorandum of Understanding** (MOU) with the **Southeast Fairfax Development Corporation** (SFDC). The MOU includes two substantive changes:

- SFDC will promote development opportunities along the Richmond Highway Corridor, with particular emphasis on those areas being incentivized for reinvestment and economic growth.
- SFDC will pursue the attraction of new businesses to the Corridor, especially retail supportive of new development, and actively work to promote and retain existing businesses.

Their efforts, along with **many other partners**, are key to the **redevelopment of Richmond Highway** as part of the Embark Plan.

The Board authorized the **Fall 2019 Fairfax County School Bond Referendum** totaling \$360M in school improvements. Three schools in our area will benefit from this funding - **West Potomac HS, Hybla Valley ES and Washington Mill ES**. Addressing the

overcrowding issues at our schools is crucial to a quality education for our children, however, **I** am not supportive of making our large schools even larger. I urge the School Board to look at redrawing school boundaries or adding new schools to address these overcrowding issues. **I** strongly support the School Bond Referendum and I ask that you vote in favor of it this fall so that we can continue to improve our school structures.

#### **Administrative Items**

**Admin 6:** Approved an **extension of the review period** for the **Mount Vernon RECenter**. This is an **administrative action** as more time is needed for a full review of the project. The full item can be read on pages 135 - 136 of the Board Package.

#### The Board authorized public hearings:

- To acquire land for **sidewalks**, **crosswalks and curbs along Quander Road** from West Potomac High School to Emmett Drive. The **Board hearing** will be held on **July 30, 2019 at 4:00 p.m.** The full item can be read on pages 39 42 of the Board Package.
- To acquire land for an **eastbound left-turn lane on Silverbrook Road at Southrun Road**. The **Board hearing** will be held on **July 30, 2019 at 4:00 p.m.** The full item can be read on pages 43 46 of the Board Package.
- Proposed amendments to change the department name from "Department of Planning and Zoning" or the "Office of Comprehensive Planning" to "Department of Planning and Development" in several chapters of the County Code. The Planning Commission hearing will be held on July 25, 2019 at 7:30 p.m. The Board hearing will be held on July 30, 2019 at 4:30 p.m. The full item can be read on pages 137 148 of the Board Package.
- Proposed amendments to the provisions related to long-term maintenance of stormwater management facilities, illicit discharges and enforcement in the Chesapeake Bay Preservation Ordinance and Stormwater Management Ordinance. This is largely administrative, but also allows violations to be processed more expeditiously. The Planning Commission hearing will be held on July 24, 2019. The Board hearing will be held on September 24, 2019. The full item can be read on pages 153 - 155 of the Board Package.

#### **Action Items**

**Action 2:** Approved a four year **Memorandum of Understanding** (MOU) with the **Southeast Fairfax Development Corporation** (SFDC). The MOU which will be in effect until June 30, 2023, includes **two substantive changes**:

- SFDC will promote development opportunities along the Richmond Highway Corridor, with particular emphasis on those areas being incentivized for reinvestment and economic growth.
- SFDC will pursue the attraction of new businesses to the Corridor, especially retail supportive of new development, and actively work to promote and retain existing businesses.

**Action 4:** Authorized the **Fall 2019 Fairfax County School Bond Referendum** totaling \$360M in school improvements for the **November 5, 2019 general election**. Three schools in our area will benefit from this funding - **West Potomac HS, Hybla Valley ES and Washington Mill ES**. The full item can be read on pages 200 - 207 of the Board Package.

Action 5: Approved the FY 2021 and FY 2022 updated funding categories for the Consolidated Community Funding Pool (CCFP), including adding a Food and Nutrition category to encompass a more holistic view of needs within the County's food system. The full item can be read on pages 208 - 214 of the Board Package.

**Action 13:** Authorized the Department of Transportation to apply for a **\$25 million federal grant** for the **Richmond Highway Bus Rapid Transit** (BRT) Project. Based on the funds approved by the Commonwealth last week, the **BRT now has half of its funding** secured. *The full item can be read on pages 298 - 301 of the Board Package.* 

**Action 14:** Approved the Department of Transportation to sign standard project agreements with the Northern Virginia Transportation Authority (NVTA), to include funding for the **widening of Richmond Highway from Jeff Todd Way to Napper Road**. **Action 14:** Approved the authorization process for a **non-public safety agency** to **operate an unmanned aircraft** system under the Public Safety Unmanned Aircraft System Program. The full item can be read on pages 397 - 453 of the Board Package.

## **Public Hearings**

Virginia Department of Transportation Six-Year Secondary System Construction Program for Fiscal Years 2020 through 2025 and FY 2020 Budget

Approved the **Virginia Department of Transportation's** Six-Year Secondary System Construction Program for Fiscal Years 2020 through 2025.

# Zoning Ordinance Amendment for Community Gardens, Farmers Markets, Gardening as an Accessory Use and Related Changes

Approved a zoning ordinance amendment to expand the locations for **community** gardens, farmers markets and home gardens.

# Amendment to the Fairfax County Tree Conservation Ordinance to Add Civil Penalties and Other Changes

Approved an amendment to the **County Tree Conservation Ordinance** to permit the imposition of **civil penalties for violations** of the Ordinance, in the same way civil penalties are imposed for violations of zoning ordinances.

## **Zoning Ordinance Amendment**

Approved an amendment to the **County Zoning Ordinance** to make several minor revisions, including permitting a **solar collection system as an accessory use** to any residential or non-residential structure and clarification of **items that can be sold at a garage/yard sale**.

#### **Amendments to the County Code: Motor Vehicles and Traffic**

Approved housekeeping changes to the County Code on motor vehicles and traffic, including **prohibiting the use of handheld devices** while driving in a **highway work zone**, punishable by a **\$250 fine**.

## **Amendments to the Police Officers Retirement System Ordinance**

Approved amendments to the **Fairfax County Police Officers Retirement System** regarding **spousal options**.

#### Alterations to the Following Small and Local Sanitary District for the De-Creation/Re-Creation of Small and Local Sanitary Districts of Vacuum Leaf Collection Service

The public hearing on changes to small and local sanitary districts for **refuse/recycling** and/or **vacuum leaf collection services** was **deferred to July 16, 2019**. This will impact residents in the **Marthas Road area**, from whom we have received a petition to stop leaf collection services. A survey of the community shows 67% in favor of stopping services. To share your opinion, whether pro or con, testify at the public hearing or submit written testimony.
