

Dear Neighbors,

At Tuesday's Board of Supervisors (BOS) meeting, we **approved the FY 2023 Budget Markup Package**, which reflects changes made to the FY 2023 Advertised Budget originally proposed by the County Executive. Adoption of the final budget, which typically does not change between mark up and approval, will be **voted on by the Board on May 10**. This budget markup comes after **weeks of hearing from residents and businesses**, including three days of public hearings, hundreds of emails, conversations with many of you, budget staff and my colleagues. **Supporting our residents**, continuing our vibrant growth and **minimizing our expenditures** have been my focus and the balance I have sought.

Our County, businesses and residents are **continuing to get stronger** as we leave the worst of COVID behind us, though our continued focus remains essential to **keep our recovery going**. My colleagues and I worked hard to **balance the increasing property valuations** and their potential tax increases with the growing supply chain disruptions, inflation cost pressures and **demands for more affordable housing**, community services, and infrastructure improvements along with competitive compensation for our County employees, **especially police and fire**, and the need to **fully fund our children's education** after past years of disruptions.

We are all experiencing **rapidly rising costs**. As a resident and homeowner, I am very aware of the impact of all these increases and **have worked diligently to mitigate** the County's contribution to that. This year, the Board has also expanded our program to help an **additional 2,000 seniors and individuals with disabilities** on limited income who may have difficulty paying their tax bill and need some relief. FY 2023 Budget Markup

The Board approved a **3-cent tax rate reduction** and additional adjustments, resulting in lowering the current rate of \$1.14 per \$100 of assessed value to \$1.11. We also approved **15% tax relief for personal property taxes**, providing almost \$98 million in total tax relief for vehicle owners. **I worked hard to lower the real estate and personal property tax rates.**

This Budget funds **community and County priorities**, maintains our Triple A bond rating and provides competitive increases for our County & school employees. We all recognize that our employees are our **biggest asset and infrastructure investments**. Through COVID, we learned that our smart, experienced staff can work their way through these difficult years. We must be **competitive in the job market** to retain them. It is especially important that we retain our public safety employees, as we prepare to open the **Lorton District Police Station** next year.

Budget Highlights:

- Reduces the real estate tax rate from \$1.14 to \$1.11
- Personal property taxes will be assessed at 85% of value (lowered from 100%)
- School request fully funded
- Compensation increases for our County and uniformed employees
- · Increased investment in affordable housing
- Lowered the M&T Machinery & Tools Tax to help small businesses

I heard from many of you about **funding for our parks**. Please know we worked closely with the Park Authority, **added additional support** and are assured they have the funding they need this year. We will continue to assess future needs.

I also advocated for **lowering the M&T tax** to help our local breweries, **fully funding schools**, improving our environment and continuing our **affordable housing** efforts, among many other issues. I am pleased we were able to expand our **tax relief program for qualifying seniors and disabled persons** and I encourage those who are eligible to apply.

It is unfortunate that in Virginia, real estate and personal property taxes are one of the **few sources of revenue available** to pay for our County school, police, fire, park and other services. Currently, the **state returns to us only about 23%** of what Fairfax County residents contribute in state taxes. (These taxes are principally contributed through the fairest and most progressive form—income taxes.) If the **state returned just 1% more** of the income tax rate back to us, we could **reduce our real estate tax rate by \$.20**! The **state also funds only approximately 23% of our schools budget**, with the balance coming from the County. In most counties south of us, the state funds schools at close to

50% or higher. **Increased state funding** for schools, public safety, mental health services, affordable housing and our many other Fairfax priorities would make a big difference in reducing the need to **County-fund these services** residents expect and need.

I thanked the Chairman, my Board colleagues, the County Executive and Deputies, and the Budget office working collaboratively over many weeks to bring this budget together. This budget also supports my core beliefs, that you have heard before - Leave No One Behind and Help All Reach Their Full Potential. As we re-envision the Richmond Highway Corridor, we must provide options for all who live here to continue to do so and provide them with a variety of opportunities for growth and development.


Uptick in COVID-19 Cases Prompts Fairfax Health District to Urge Continued Vigilance

Over the past two weeks in the Fairfax Health District, cases of COVID-19 have risen by 62%; and since a low on March 21, the daily number of cases has abouttripled. Although not as high as the peak in cases seen in January, this change is concerning. Just during the past week, there have been 15 new outbreaks (clusters of three or more connected cases of illness) reported in the county with 12 occurring in schools and daycares. Despite this surge in cases, hospitalizations continue to be low, and the community level remains at "low." Learn more...

Public Meeting: Fiscal Year 2023-2028 Six-Year Transportation Improvement Program

The Commonwealth Transportation Board (CTB) will conduct a public meeting to give the community the opportunity to provide comments on transportation projects and programs to be included in the Fiscal Year 2023-2028 Six-Year Improvement Program (FY23-28 SYIP). These projects and programs, which include highway, rail and public transportation initiatives, represent important improvements to address safety,

congestion and preservation of Virginia's transportation network.

This CTB meeting as required by §33.2-214.3 code of Virginia, will serve as the **joint public meeting** for the following six agencies: the Virginia Department of Transportation (VDOT), the Virginia Department of Rail and Public Transportation (VDRPT), the Northern Virginia Transportation Authority (NVTA), the Northern Virginia Transportation Commission (NVTC), the Virginia Railway Express (VRE), and the newly established Virginia Passenger Rail Authority (VPRA). Each organization will have information available for review and comment related to their respective projects, evaluation, and selection criteria for funding.

The public meeting will be held on **Wednesday**, **May 4 at the VDOT Northern Virginia** (**NOVA**) **District Office**, located at 4975 Alliance Drive, Fairfax. The **open house** will begin at **5:30 p.m.**, followed by a **listening session** at **7:00 p.m.** Formal **public comments** on projects proposed to be included in the draft SYIP will be **accepted at the meeting** and **online until May 23**.
